DESCRIPTION

Located in the city of Bartlett, a suburban community of nearly 36,000 northeast of Memphis, the Nicolas Gotten House was built in 1871. The residence is situated on a 1.2 acre lot that is surrounded by a white picket fence and dotted with mature trees. A quiet residential street containing mostly one-story bungalows and a few two-story modern houses make up the surrounding neighborhood. Rising two-stories from its brick pier and concrete block foundation, the Gotten House is a frame building sheathed with weatherboard siding and capped with a roof covered with asphalt singles. The main block of the house consists of a central hall plan that is two rooms wide and one room deep and accompanied by a rear extension and a twentieth century one-story addition. The extension is one and one-half stories, which runs the width of the rear of the main block and is probably original to the house, or an early addition. Constructed in the early twentieth century, the rear one-story addition runs only half the width along the rear of the extension. Both the extension and addition rest on brick pier foundations and are covered with weatherboard siding. Together, these rear extensions with their sloping roofs, create a saltbox roof form that adorns the Gotten House.

The house is owned by the city of Bartlett and is leased to the Bartlett Historical Society. During the course in which the historical society has occupied the building, the Gotten House has undergone an extensive restoration. This includes the reconstruction of the two-story front portico, new six-over-six, double-hung, sash, wood shutters, latticework between the brick piers, mantles, and the replacement of deteriorated plaster walls with modern dry wall. The exterior restoration was based on a photograph of the house from the 1920s. The interior retains its original plan and woodwork.

A central two-story portico and three front-facing gables that accent each bay highlight the symmetrical three-bay east façade of the Nicholas Gotten House. Although the portico is not original to the house, it is a superb reconstruction of the original in design and scale. Simple square columns, balustrades with tapered balusters and a beaded board ceiling support the wood portico. Railings, which are required by local codes, with accompanying newel posts along the entry stairs are the only deviation from the original design of the portico. A newly laid brick walk leads to the main entrance of the house, which consists of a modern six-panel wood door. Flanking sidelights with a recessed panel in the lower portion and a six-light transom complete the door surround. Access to the portico from the second floor is achieved through a multi-light wood door with flanking sidelights containing a recessed panel in the lower portion. The central bay is flanked by two window openings on each story containing six-over-six, double-hung, wood sash and adorned with wood shutters. Providing a decorative, yet functional, treatment to the Gotten House are the half moon attic vents that adorn the fields of each front facing gable.

The north elevation is divided into three-bays consisting of the house and the two rear extensions that are flush with the original block. Two window openings containing six-over-six, double-hung, wood sash pierce each floor of the gable end of the main block. Wood shutters accent each window, while a pointed arch louvered attic vent is located in the gable field. A square window opening containing six-over-six, double-hung, wood sash with accompanying wood shutters punctuates the first rear extension, which is divided from the main block by a vertical board. Completing the detailing on the first extension is a square louvered vent located in the half-story. The last bay, divided from the first extension by a vertical board, reveals a double-hung window.

The west elevation has an early twentieth century addition that is pierced with a large square window containing twelve-light fixed wood sash. According to museum director Mrs. Jeanette Rainey, this addition was originally constructed as a rear porch, but was enclosed in the 1950s. South of the window is a door opening containing a solid wood door. This addition, although flush with the north elevation, does not extend to south elevation. South of the addition are two window openings containing six-over-six, double-hung wood sash, which are not flanked by shutters. A concrete handicap access ramp with a metal rail extends north from the door to a parking pad located on the northern portion of the property.

The south elevation reveals two window openings on the gable end of the main block. Like the majority of the windows, these are six-over-six, double-hung, wood sash. A window opening on the second floor consists of the same light pattern, which is joined by a pointed arched wood attic vent above. Wood shutters flank all of the windows. West of the main block is a window opening, adorned with wood shutters, containing six-over-six, double-hung, wood sash that is accompanied by a square louvered attic vent. Paired multi-light windows are located on the addition.

The interior of the main block of the Gotten House follows a standard central hall plan with an entry hall flanked by two parlors. A simple open string staircase complete with a tapered newel post highlights the central hall. A small closet is located underneath the staircase. The two parlors that flank the central hall, as with the hallway, retain their original baseboards, hardwood floors and door trim. The ceilings in the parlors reach approximately eight feet, with the south parlor containing a non-original metal mantle. This mantle is a simple design, composed of a plain mantelshelf, decorative keystone, and pilasters.

Access to the first extension is achieved through two door openings, one at the end of the main hall and the other found on the west wall of the north parlor. This area of the house contains a kitchen, two rooms utilized for display and small hall that provides access to the north parlor and the first story rear addition. Consistent with the rooms found in the main block, the rear extension contains original hardwood floors, door trim and baseboards; however, the kitchen contains modern cabinets and appliances. The rear one story addition contains a bathroom and a room

used to store archival material. A modern sink and toilet are found in the bathroom along with modern tiles. The archival room reveals hardwood floors and simple window molding.


The south wall of the upstairs hallway contains a wood door made of vertical planks that lead to the attic. Two bedrooms highlight the second floor of the Gotten House. Both rooms retain their original baseboards and trim molding for the door and window openings. Hardwood flooring also accents each room, which contains sloping ceilings that conform to the saltbox roof that caps the building. Each bedroom has a modern closet that project from the west walls.

Located directly behind the Gotten House is a simple circa 1990 wood frame structure that serves as a public restroom. The restroom is sheathed with wide weatherboard siding, capped with a gable roof covered with asphalt shingles and rests on a concrete slab foundation. (NC)







SIDE - SOUTH ELEVATION




SIDE - NORTH ELEVATION

First floor plan



STATEMENT OF SIGNIFICANCE

The Nicholas Gotten House is nominated to the National Register of Historic Places under criterion B for its local significance with Gotten, an important businessman in the community. Nicholas Gotten arrived in Bartlett in 1860 and immediately began to have an impact on the town, then known as Union Depot. Gotten operated a gin and mill, patented a gin feeder, and was elected the community's first Constable. Although the Nicholas Gotten House was altered over the years, the City of Bartlett has restored the house to the period when Gotten resided. The house retains its overall integrity.

Nicholas Gotten was a native of Prussia, born August 17, 1832. The family lived in Spangdahlen, Germany, near the French and German border. At age twenty-two, he immigrated to the United States of America and spent four years in the north before moving to Memphis, Tennessee in 1858 and then to Union Depot (Bartlett) in January 1860.

Union Depot was a rural community providing essential commercial services to the early settlers of the area. The settlement was named Union Depot when the Ohio Railroad was built through the area in the early 1850s. Shortly after arriving, Nicholas Gotten purchased lots along the stagecoach route (now known as Stage Road) near the railroad and started his businesses. He first established himself as a blacksmith and then added milling and cotton ginning, all important services to the residents of Union Depot and the nearby farming communities.

When the Civil War began in 1861, Nicholas considered joining the Confederate Army. However, friends convinced him to stay home, since his occupation was so important to the community. But in 1862, after the fall of Fort Donelson (NR 10/15/66, National Military Park), he could not be restrained and enlisted in Company C, Third Cavalry, under the command of General Nathan Bedford Forrest. He fought bravely at Shiloh (NR 10/15/66, National Military Park), Corinth (NHL 5/6/91, Siege and Battle of Corinth), Britton's Lane, luka, Thompson's Station, and numerous other engagements. On May 3, 1864 he was seriously wounded while fighting at Bolivar, Tennessee. After several months of recuperation in private homes in the Bolivar area, he was captured by Federal troops and then exchanged. He continued his military service until the war ended.

After his return from the war, Gotten returned to Union Depot and resumed his business interests. Union Depot was renamed the Town of Bartlett and incorporated in 1866. According to the *Memphis Daily Appeal* of May 3, 1867

The town of Bartlett is incorporated, a charter having been granted by the last legislature. It is a beautiful little town, only eleven miles from the city, on the Ohio

railroad, improving considerably, with a population of three hundred. Several of our merchants reside at Bartlett.

G.M. Bartlett was elected Bartlett's first Mayor; W.T. Pryor, Dr. Wright, J.B. Mercer, H.I. Priddy, and Dr. Nicholas Blackwell were the first Aldermen; and Nicholas Gotten was elected the town's first Constable.

Nicholas was married to Julia S. Coleman, a daughter of Steven Coleman and sister of a Confederate comrade, James Coleman, on January 26, 1869. He and his bride took up residence in a house on the northwest corner of Blackwell Street and Sycamore View. On September 28, 1870, he purchased lot number 84 at the southwest corner of Court and Woodlawn streets from Dr. Nicholas Blackwell and William T. Pryor for \$300. According to the Trustee's records, the house known as the Gotten House at 2969 Court Street was built on that lot in 1871.

Nicholas and Julia had three children: Peter Monroe Gotten, born March 1870; David Henry Gotten, born September 1873 and Maggie Amelia Gotten, born December 1877. The sons both married and had families but the daughter never married.

As a blacksmith, ginner, and miller, his services were considered valuable among the people of the Bartlett area. Gotten worked to improve a cotton gin feeder and submitted a patent to the U.S. Patent office. He was granted patent no. 239.380 on March 29, 1881. However, he did not have the financial means to produce the cotton feeder on a commercial scale, so his invention was never profitable for him.

On June 27, 1910, Gotten sold his cotton gin and commercial lots to his son, D.H. Gotten, for \$4,000 and retired from business. On August 27, 1919, four days after his 87th birthday, he passed away, leaving his residence to his spinster daughter, Maggie. He was buried in Forest Hill Cemetery in Memphis. His wife had died January 13, 1892 and was buried in the back yard of their home, but in 1920 her remains were exhumed and reburied beside her husband.

This family has been prominent in this community for more than 140 years. Nicholas' three children lived here all their lives. David Gotten, his grandson, and wife, Willie, lived here until their deaths. David owned an insurance agency and was a Bartlett Alderman for twenty years during the 1960s and 1970s. Nicholas' great granddaughter and her son, Michael Elder, still reside only a few blocks from the home their ancestors built. He and his bride Shirley were married at the Gotten House on April 15, 2000.

The Nicholas Gotten House remained in the family until 1948 when. The City of Bartlett purchased the house and used it for many years as a police station annex and jail. Presently, the




