Recent Successes

Summer of Service Story

110 teenage youth from urban Denver participated in summer conservation programs through AmeriCorps NCCC (National Civilian Community Corps) and Groundwork Denver in 2009. The summer experience culminated in groups of 10 youth, with crew leaders, being dispatched to multi-day camping trips in national and state parks and wilderness areas. Each team's experience included on-the-ground conservation work, natural resource education, and opportunities for recreation. In one case, AmeriCorps NCCC crews, in cooperation with the National Park Service, the USDA Forest Service, and the Mosquito Range Heritage Initiative, built six drainage dips, two rock walls, and installed a trailhead kiosk in Pike National Forest.

1. Huerfano County Trails

Project Partner: Huerfano County Board of Commissioners RTCA Contact: Joy Lujan Location: Huerfano County

Project Goal

An interconnected system of trails, open space, and parks in Huerfano County.

RTCA Role

Coordinate between multiple organizations to compile existing information regarding regional conservation priorities and develop alternative trail alignments that accomplish county-wide recreational goals.

2. Lake Nighthorse Recreation

Project Partner: Animas-La Plata Water Conservancy District RTCA Contact: Joy Lujan Location: Durango

Project Goal

Ten miles of trail connecting to the City of Durango's River Trail System, recreational access to 1,500 acres of water, and 5,444 acres of land preserved or enhanced for recreational use.

RTCA Role

Design, coordinate, and conduct the process for gathering public input which will shape the conceptual recreation plan for the area surrounding Lake Nighthorse.

3. Mesa County Old Spanish NHT and Gunnison Bluff Trails

Project Partner: Mesa County, City of Grand Junction RTCA Contact: Kay Salazar Location: Grand Junction

Project Goal

Conserve and improve ten miles of trail and create new trail loops with

RTCA Role

4. Lake Fork River Enhancement

Project Partner: Lake Fork Valley Conservancy RTCA Contact: Kay Salazar Location: Lake Fork of the Gunnison River and Henson Creek, Lake City

Project Goal

Enhance and protect the ecological health and recreational quality of the Lake Fork of the Gunnison River and Henson Creek to improve fisheries, riparian areas, river hydrology, recreation, and river access in the Lake City region.

RTCA Role

Help the Lake Fork Valley Conservancy develop a collaborative plan to guide project partners in reaching their goal to improve the ecological function and enhance recreation opportunities. Conduct community involvement in cooperation with project partners and target outreach to landowners, boating, fishing, and environmental interests and other stakeholders.

5. Sangre de Cristo National Heritage Area

Project Partner: Sangre de Cristo National Heritage Area RTCA Contact: Alan Ragins Location: Designated National Heritage Areas includes Alamosa, Costilla, and Conejos counties

Project Goal

Potential for open space, conservation, and trail development related to the Alamosa Ranch, San Luis communal open space and aceqeuias, Rio Grande River and other areas.

RTCA Role

Help identify and support on the ground action priorities and help develop implementation partnerships. Assist with organizational development and facilitate strategic public engagement.

6. Silverton - Animas River Revitalization

Project Partner: Town of Silverton, San Juan County, Mountain Studies Institute RTCA Contact: Hugh Osborne Location: Silverton

Project Goal

New trail mileage in and around Silverton that will include adaptive re-use of abandoned lands to create an attractive park and enhancement of up to seven miles of the Animas River corridor.

RTCA Role

RTCA staff has trained local residents in the maintenance of existing trails and how to build new trail. Staff planned and designed trails that are located on lands owned by the Durango Silverton Narrow Gauge Railroad, a major tourist attraction in the area. RTCA staff also developed a trail across a wetlands area that will provide a better experience for the users and better protect the sensitive landscape. "The help provided by RTCA has really kept this project moving forward. What we've learned will make it possible for new trail opportunities in the future."

7. Heritage Education at Bents New Fort

Project Partner: Semmens Family, Colorado Historical Society, Bent's Old Fort National Historic Site RTCA Contact: Hugh Osborne Location: Bent's New Fort Historic Site

Project Goal

Rivers and Trails staff is creating a conceptual management strategy for this historically significant site located on the Santa Fe National Historic Trail in southeastern Colorado. Working cooperatively with the site owners, nearby National Park units, and several other groups interested in preserving the history of Colorado, the strategies include options for site development, interpretation, and the protection of the cultural resources found on this site.

RTCA Role

RTCA staff will help collaborate these activities over the course of involvement.

8. Kiowa County Heritage Trails

Project Partner: Kiowa County Historic Preservation Commission RTCA Contact: Joy Lujan Location: Kiowa County

Project Goal

A county-wide system of recreational trails linking cultural and natural resources that provide recreational and interpretive opportunities for county residents and visitors.

RTCA Role

Work with partners to identify which community-identified heritage resources will be connected via recreational trails and driving routes and develop trail alignment alternatives based on communitydefined criteria. Identify and engage other resource experts for interpretation and preservation needs.

Recent Successes cont.

After weeks of outdoor stewardship work in Denver, the young members of the Groundwork Denver Green Team ventured to Great Sand Dunes National Park and Preserve to remove invasive plant species and enjoy the park's natural beatuy. At the summit of High Dune, an 8,691-foot sand peak, one inspired young participant exclaimed, "If I can do this, I can do anything! The summer conservation experience connected young people to the outdoor world, inspired a conservation ethic, and helped young participants understand their ability to care for the natural world.

Bent's New Fort Awarded Grant

The Bent's New Fort site was awarded a grant from the Colorado Historic Fund to conduct a professional archeological assessment of the area. This assessment, in conjunction with the local designation of historical significance, will lead to a nomination of the site for the National Register of Historic Places.

Walsenburg Youth Clear the Way for the Cucharas Riverwalk

In late April more than 80 local youth joined Huerfano County, youth sports groups, the Department of Social Services, Parks & Trails Advisory Group, and the National Park Service to complete the first of many steps toward a transformed Cucharas River experience in Walsenburg. Youth and crew leaders leveled out more than 1000 feet of trail, built a rock wall to prevent trail erosion, cleaned up trash in Fiesta Park, and eradicated the Russian Olive and Tamarisk invasive species near the river. The Cucharas Riverwalk is envisioned to offer Huerfano County residents and visitors a pleasant walk through picnic areas, amphitheater entertainment, and natural beauty. The trail will run just east of Fiesta Park along the Cucharas River to Bear Creek Road.
