Summary Paragraph

The gray granite Little River marker is located 5 miles north of Ashland, on the west side of Washington Highway, Route U.S. 1 in a wayside turnout on the southern end of the Little River bridge in Hanover County, Virginia. The marker is one of sixteen erected in Virginia along the Jefferson Davis Highway between 1927 and 1946. The Jefferson Davis Highway was a nationwide memorial project of the United Daughters of the Confederacy (UDC) beginning in 1913 and continuing until 1947 when the highway's terminal marker was placed in Arlington, Virginia.

Description: Gray granite, 49" tall, 29" wide and 21" thick, set on a 9" granite base Date: 1936
Significance of location: Gen. R.E. Lee's left wing rested near here May 23-26, 1864 while his army faced Gen. Grant on the north side of North Anna River. The marker has a high degree of historic integrity.

Narrative Description

The Little River Marker is a gray granite pedestal with a sloping top. The rough-cut granite pedestal is 49" tall, 29" wide, 21" thick and rests on a 9" granite base. Within a recessed panel, its sloped face reads:

Engraved on the front face of the stone within a smooth recessed panel is:

The marker faces northeast toward U.S. Route 1 and sits on the embankment of Little River. The marker appears to be leaning on the west side toward the embankment of Little River. The embankment is reinforced with mortared stones. Viewing the marker below the embankment it is in alignment and is not leaning.

Originally, the sloping face had a bronze plaque bolted to the stone. However, after it was stolen twice, the UDC had the same words inscribed on the stone face. This is not considered a loss of integrity.

Statement of Significance Summary Paragraph (Provide a summary paragraph that includes level of significance, applicable criteria, justification for the period of significance, and any applicable criteria considerations.)

The Little River Jefferson Davis Highway Marker is being nominated for listing in the National Register of Historic Places under the Multiple Property Documentation Form, UDC Commemorative Highway Markers along the Jefferson Davis Highway in Virginia. The markers included in the MPD meet Criterion A in the areas of Transportation and Social History and are significant at the statewide level because they are associated with the period of “named highways” in U.S. history beginning in 1913 and because they represent a significant achievement for a women’s organization. The period of significance is 1936, the year the marker was erected. As a commemorative resource, the Little River Marker meets Criteria Consideration F. The marker is primarily commemorative, yet it possesses symbolic value and its own historical significance as part of this early attempt to mark a cross-country highway as a memorial to the first and only President of the Confederate States of America.

Narrative Statement of Significance (Provide at least **one** paragraph for each area of significance.)

The Little River Marker is one of sixteen Virginia Markers erected along the Jefferson Davis Highway (U.S. Route 1) between 1927 and 1947 as a memorial to Jefferson F. Davis, first and only president of the Confederate States of America. All sixteen markers are listed in the MPD UDC Commemorative Highway Markers along the Jefferson Davis Highway in Virginia in the inventory of associated property types. These markers remain standing and despite the minor relocation of several markers to address highway safety concerns or to improve traffic flow, all retain their historic relationship to U.S. Route 1, which, for the most part, constitutes the route of the Jefferson Davis Highway through Virginia. The markers were paid for and erected and maintained by the United Daughters of the Confederacy (UDC) through local UDC Chapters, the Virginia Division of the UDC and the General Organization of the United Daughters of the Confederacy. This activity was replicated in the other former Confederate States and was a part of a cross-country route mapped as the Jefferson Davis Highway and promoted by the United Daughters of the Confederacy through educational brochures and travel publications.

As detailed in the MPD, the establishment of the Jefferson Davis Highway, the erection of the markers honoring Confederate President Jefferson Davis, and the publications of maps and educational brochures about the locations through which the cross-country route passed is considered by the United Daughters of the Confederacy to be one of its greatest undertakings. Mrs. Alexander B. White, President General of the United Daughters of the Confederacy, conceived the idea for the Jefferson Davis Highway in 1913, following the establishment of the Lincoln Highway earlier that year. From 1913 until about 1925, it was common for private organizations to identify a route, give it a name and promote its use and improvement. The Highway was not built as a new highway, but instead was created by designating existing routes and then petitioning each state for formal recognition. The Jefferson Davis Highway, as it was originally proposed and printed as a map in 1920, extended a distance of 3,417 miles from

Arlington, Virginia, to San Diego, California, and then north up the Pacific coast to the Canadian border. By 1923 the name Jefferson Davis Highway was official in six states. The Virginia section of the highway extends from the Potomac River Bridge at Arlington, through Fredericksburg, Richmond, and Petersburg to the Virginia/North Carolina state line, a distance of 235 miles. Virginia's General Assembly designated U.S. Route 1 as the Jefferson Davis Memorial Highway in March 1922. By 1929 the name was being used in all the states it traversed except California, which did not designate names for any memorial highways. Even after the official highway numbering system replaced the named highways in 1926, the UDC continued to print maps and brochures for the Jefferson Davis Highway in 1929, 1931 and 1938. Today, most named segments have been dropped or changed, with Virginia's Southside segment along US Route 1 being one of the few that has survived.

The 1937 Jefferson Davis Highway Committee, Virginia Division Minutes of the United Daughters of the Confederacy, chaired by Mrs. B.A. Blenner reported the boulder [marker] was erected on October 2, 1936. The Landscape engineer had designed a wayside on the property owned by the State Department for the boulder. Plantings were also planned for the site. The cost of the boulder was 165.00. The bronze plaque was stolen twice, November 1936 and 1978. After the second theft the UDC had the same words engraved directly into the stone: JEFFERSON DAVIS HIGHWAY VIRGINIA.

The site for the Little River marker was chosen because on the bank of the Little River stream and to the west, General Robert E. Lee's left wing rested while his army faced Grant on the North Anna River, May 23-26, 1864. The Caroline Grays Chapter UDC currently maintains the marker, and it sits on land owned by the Virginia Department of Transportation

The Little River Jefferson Davis Highway Marker meets the registration requirements stated in the in the MPD for UDC Commemorative Highway Markers along the Jefferson Davis Highway in Virginia. The Little River marker retains its integrity of location, setting, design, workmanship, feeling and association. Although the area surrounding the marker has changed since 1927 and despite its minor relocations, the marker retains its historic association with the highway. The design of the marker has not changed in the years since its erection. The workmanship of the marker has not been altered in the years since 1936; however, the bronze plaque placed on the sloped face of the marker has been stolen twice. Because the words from the bronze plaque were etched into the stone following the second theft, according to the MPD, it is not considered a loss of integrity. The marker's integrity of feeling is intact. It retains a simple dignity and the feeling of an earlier age of travel when markers by the side of the road were more easily seen and appreciated by the passing public. Finally, the marker retains its integrity of association, conveying its origins as a historical memorial.

The Virginia Department of Transportation pull-off where the Little River marker is located at one time also contained a metal Virginia Historical Marker with the following text:

E-19- LEE'S LEFT WING-

The sign, which was south of the marker, is currently missing; however, the metal pole to which it was attached remains intact.

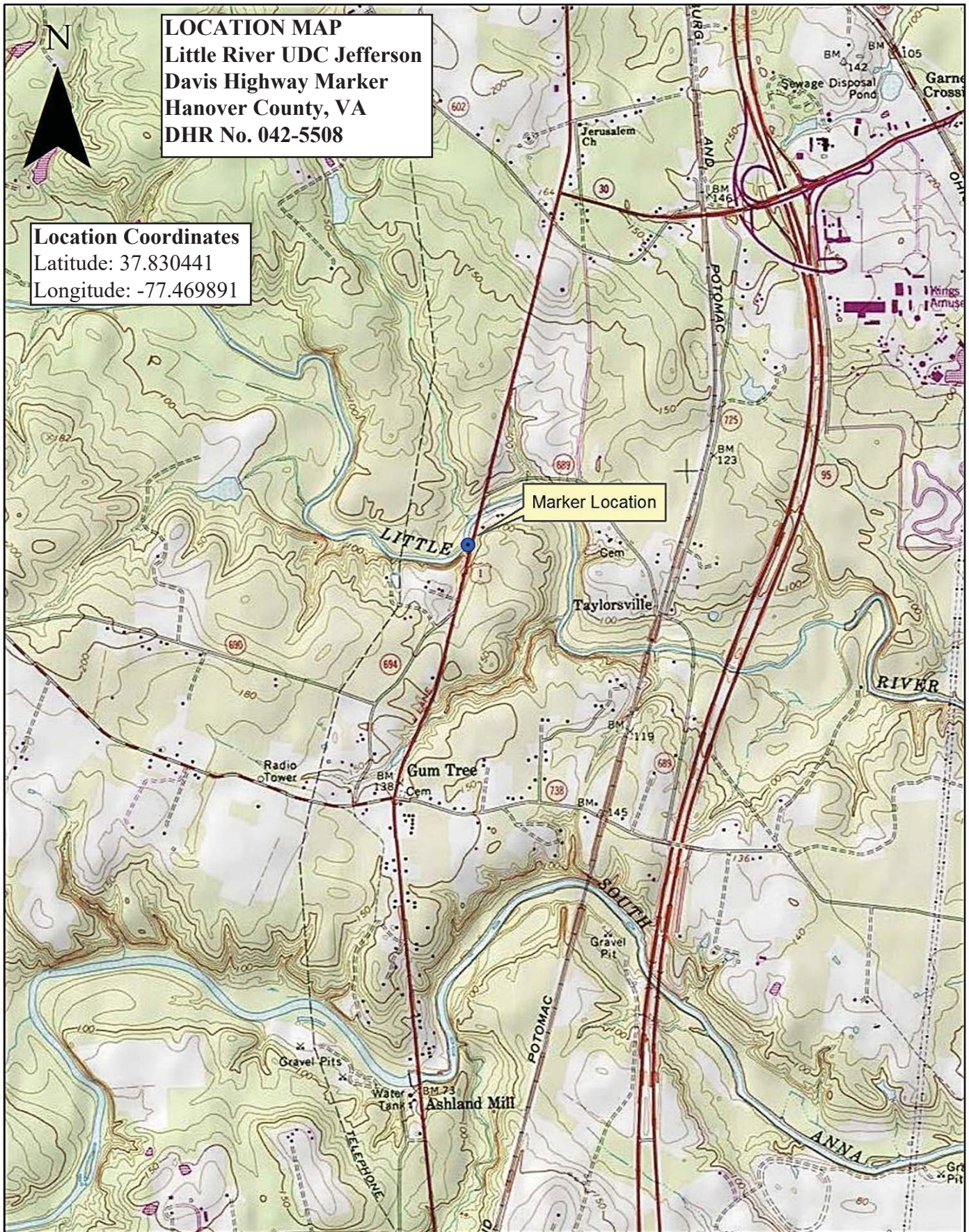

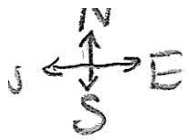

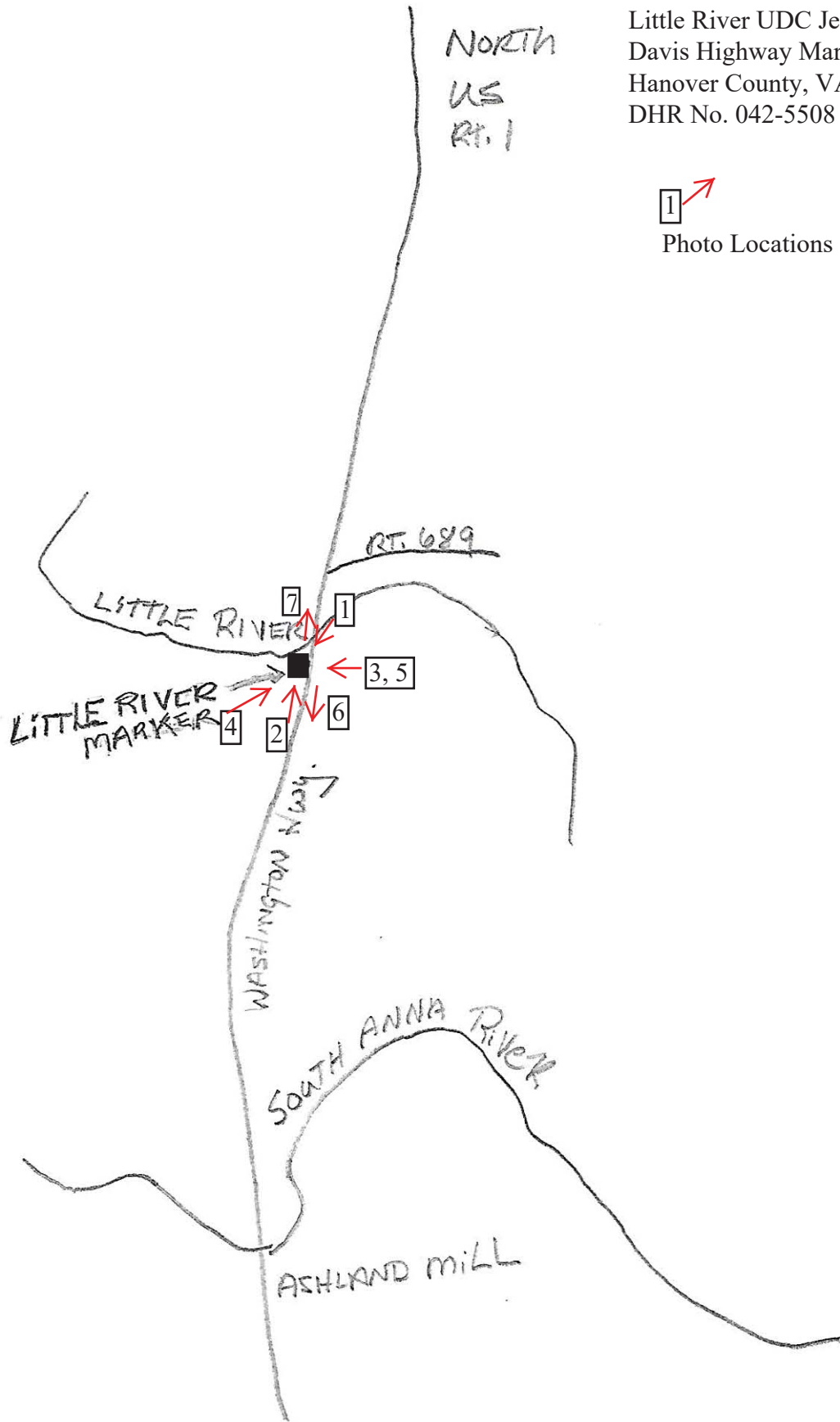


SKETCH MAP/ PHOTO KEY
