DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

The Sheriff Campbell house is set near the corner of a one-acre lot in a low density residential area immediately behind the Mississippi River levee. Although the Mississippi River bridge is screened off by trees, it passes within 100 feet of the rear of the house, thereby creating a major auditory and visual intrusion. But the presence of the bridge is mitigated somewhat by the spacious immediate setting provided by the large lot.

The house has a large, boxey, and essentially symmetrical form. But the interiors exhibit a strong sense of space. Over a third of the ground floor is taken up by a large, Queen Anne living hall-dining room combination. This long room contains two fireplaces, an octagonal alcove set in the corner of the building, and an "L" dining extension at the far end. The heavily paneled and newel-posted staircase has two turns which give it a somewhat sculptural appearance. Its strong visual presence is owing to its massiveness, and to its central position between the living hall and dining area. There are two smaller parlors which communicate with the adjacent living hall-dining room by means of a combination of immense paneled, sliding doors. Though they are somewhat diminished by alteration, they still spread to an opening of over fifteen feet. When they are in their fully open position the three main rooms are visually united.

To the rear of these public rooms is a kitchen, a back stair, and a service area. The upstairs bedrooms are set along a hallway which runs from front to rear of the house. The only change in plan has been the enclosure of the upstairs porch which occurs in the center of the main facade.

The house features standard turn-of-the-century wood frame construction.

The square, boxey, hip roofed exterior features colonial revival details. The main facade features a central gabled pavilion which encompasses a two-story porch. The upper story has been enclosed, but the columns (which are now in the attic) could be put back and the enclosure removed. The fenestration on the ground floor does not harmonize well with the column spacing in the front and side galleries. The columns are of the stubby, catalogue ordered variety with Ionic capitals. Most of the windows have large, plain plate glass sashes, with the exception of the front door transom which is leaded.

The interior detailing is also catalogue ordered.

All the fireplaces have standard, turn-of-the-century, oak mantels with mirrored overmantels. The entrance to the alcove in the living hall-dining room is decorated with scroll-saw ornamentation formed of dowel rods, knobs, scrolls, and anthemion motifs. Most of the original ceiling fans and milk glass light fixtures remain.

STATEMENT OF SIGNIFICANCE

The Sheriff Campbell House is significant in four areas. Its political and social significance derives from its association with its builder, Eugene P. Campbell, who as sheriff of Concordia Parish from 1908 until his death in 1940, was a major figure in the town's political history.¹ Campbell built the house with the idea of making it a social center for the area and a place to entertain his numerous friends and political associates. The testimony of many longtime residents of the area concerning the "beautiful parties" given by Sheriff and Mrs. Campbell suggest that he fulfilled this ambition. The large sliding doors on the first floor could be thrown open to produce a sizable ballroom or dining room or whatever type room the occasion required.²

The Sheriff Campbell House is also significant in the area of local history, because it is one of only three homes not moved or demolished in 1939, when the entire town of Vidalia was moved about one mile west in order to allow for the widening of the Mississippi River and the construction of a larger levee. Of the three homes not moved, the Campbell House is the largest and most architecturally impressive, and is thus the present town's most notable physical link with its history prior to 1939.³

The house also possesses architectural significance. The Queen Anne Revival in Louisiana consisted mainly of applying a few Queen Anne features such as a bay window, a diminutive turret, or a curved porch to the standard Louisiana raised cottage form. The Sheriff Campbell house is unusual in having a fully developed Queen Anne living hall plan with a monumental staircase and a cohesive flowing together of interior spaces. The Campbell house is one of the few examples of this in northeastern Louisiana.

Campbell had the house built about 1915. In July of that year he purchased the 2½-acre lot on which he built the house from J. L. Fairbanks and Mabel Swayze in return for a consideration of \$675.⁴ Although the home had no architect, according to a statement by Campbell's nephew Michael J. Schuchs, "some of the floor plan" was copied from a friend's house on Linton Avenue in Natchez. Schuchs also states that it was Sheriff Campbell's wife Rhettta who was primarily responsible for the design.⁵ The home's contractor was Frank Ketteringham, a local contractor active in the area during the late nineteenth and early twentieth centuries.⁶ The total cost of construction is unknown, but the cost of the labor was \$4,500.⁷

After Sheriff Campbell's death in 1940, the house passed through the hands of several owners until the present owners obtained it in 1966.


