Summary Paragraph

The Faith Cabin Library at Seneca Junior College, built in 1937, is located on South Poplar Street near its intersection with West South 3rd Street, in the town of Seneca, in rural Oconee County, South Carolina. It is situated near a northeastern facing hill. The library is an inverted T-shaped, lateral-gabled building oriented to the southwest. It is of log construction with chinking and the front or main portion of the building appears to be set on a stone foundation, while the centered rear gabled wing appears to sit atop concrete piers that have been in-filled with corrugated metal. The roof is covered with V-crimp metal sheets or galvanized tin. It is the only building remaining from the Seneca Junior College campus, as all other buildings were razed in 1963. A large metal and brick multi-purpose building, housing the Seneca Institute Family Life Center, was built on the site of the college in 1978. Although immediately adjacent to the Faith Cabin Library, this modern building is excluded from the boundaries of the nominated property.

Narrative Description

The façade (southwest elevation) of the Faith Cabin Library features a central engaged, vertical plank-clad gable that projects slightly to cover the double-leaf wood plank entrance doors. A single one-over-one light, double-hung sash window is located to either side of the door. Along the northwest elevation of the building is a tapered or battered stone chimney. A single one-over-one window is on each side of the chimney. The exposed gable shows horizontal wood planking. The rear addition can be seen with the metal reinforcing the stone foundation underneath.

Along the northeast elevation of the building is the rear wing addition to the log cabin. The rear addition is of log construction as well, is gable-fronted with horizontal wood planking in the gable. Within the gable is a small fixed four-light window. To the right of the window is a small circular opening that likely accommodated a heater or stove pipe when the library was operational. Below the window is a larger one-over-one window. Wooden knee brackets support, at least visually, the projecting gable overhang/eave. At the foundation level at left of center is a small wooden access door for the area beneath the building. Along the southeast elevation of the building is a gable with horizontal wood planking as well. Set in the wood planking is a small window. Set in the logs beneath the upper window are two one-over-one windows. Knee brackets are also visible on this gable end. The rear addition can be seen with the metal foundation visible.

Faith Cabin libraries in South Carolina, built from 1932-1943, fall into two subtypes based on physical and associative characteristics. The Faith Cabin Library at Seneca Junior College, built in 1937, falls under Subtype 1: Free-Standing Log Cabins, within the Property Types section of the Faith Cabin Libraries in South Carolina, 1932-1943, multiple property documentation form. The wood for construction was supplied by the local community. This library is a two-room building with a roughly-coursed granite chimney, culled from local supplies. There exists little documentary evidence beyond this narrative description; however, the property still possesses architectural integrity to convey its historic function and be nominated to the National Register for Historic Places.

The Faith Cabin Library at Seneca Junior College is significant from 1937, when it was built, to 1939, when Seneca Junior College closed, for its role in African American education and social history in Oconee County and upstate South Carolina during the Great Depression of the 1930s.

The Faith Cabin Library at Seneca Junior College, located in the town of Seneca, in Oconee County, South Carolina, is significant under Criterion A for its role in African American education and social history in South Carolina between 1937 and 1939. This building, constructed in 1937 and known as the Oberlin Unit because it was largely the result of the interest and efforts of students at Oberlin College, Oberlin, Ohio, is important on a local level for its impact on the African American community in Oconee County, and on the state level as one of only two remaining free-standing Faith Cabin Libraries extant of the thirty built in South Carolina between 1932 and 1943.

Narrative Statement of Significance (Provide at least one paragraph for each area of significance.)

Criterion A – Education / Ethnic Heritage – African American

The Faith Cabin Library at Seneca Junior College was a part of the larger Faith Cabin Library program that offered library services to African Americans in South Carolina. The segregation laws of the late nineteenth and early twentieth centuries, known as "Jim Crow" laws, barred African Americans from using other library facilities beyond what was offered in Columbia and Charleston. Created between 1932 and 1943, Willie Lee Buffington, a white textile worker who later became a Methodist minister and college professor, established thirty Faith Cabin Libraries in South Carolina which offered many African Americans the only means of access to library services and library books.¹

The black community residing in Seneca, South Carolina was one of the thirty communities fortunate to participate in the Faith Cabin Library program. With donated money and timber from the community, and books from the students of Oberlin College, Buffington established the library, a free-standing log cabin, on the campus of Seneca Junior College. This denominational Christian college, founded by the Seneca River Baptist Association in 1899 as the Seneca Institute, a primary and secondary school for African Americans, changed its name to Seneca Junior College in 1926 when it added two years of college instruction. When the Faith Cabin Library program began, the faculty of the college contacted Buffington to build a library on the campus. The library was built in 1937.² The library remained open for only two years, when in 1939 Seneca Junior College closed its doors due in part to the construction of a new black high school nearby and the economic impact of the Great Depression.³ It is one of only three known Faith Cabin Libraries to remain extant in South Carolina, out of an original thirty that were built.
