

1. Name: Ysabel Valencia House, survey number 62

2. Location: Approximately 3/10 of a mile east of Highway 61 and 1 mile south of Mimbres

4. Owner: Ronnie Montoya, Rt. 16, Box 4625, Mimbres, N.M. 88049

7. Description: Photos 36,37; map 8; L-shaped; concrete foundation skirt; stuccoed adobe; hipped corrugated metal roofs; 2/2 double hung windows; single doors; paired 2x4s as porch supports. Associated barn: photo 39, horizontal log with double saddle notch, hipped corrugated metal roof.

8. Significance: This farmers house and barn meet Criterion A as good representatives of the historic importance of agriculture in the valley. Built in 1930, this house is a good example of the New Mexico Vernacular type and therefor meets National Register Criterion C. Typical of some other houses of this late date, the building has not only a hipped roof but has moved part way toward a rectangular plan. The associated barn is notable as the sole remaining log barn in the valley and it too meets Criterion C. Because timber was once readily available at this north end of the valley, there were likely more log barns once. Log notching in the southern part of the state has not been studied, therefore, this barn may be an important example. Interestingly, this barn uses unhewn logs and has double saddle notching, which, in north central New Mexico, is thought to be an Anglo-American introduction while hewn logs and double box notching have been identified as the traditional Hispanic form.


Verbal boundary: A polygon, roughly 140' by 100', as shown on map 8, formed by lines parallel to and ten feet from the north and west sides of the house and the east and south sides of the barn. Since this is an unplatted area, this boundary has been created to include only the house and barn.
