

The Jack Dudney House is a rambling frame late victorian cottage with Colonial Revival styling, situated on a high terrace above the right of way for West Poplar Avenue (State Highway 57) in the Town of Collierville (pop. 7,839, 1980 Census), located in the southeastern corner of Shelby County, Tennessee. Built in ca. 1911-1912 for John Frank (Jack) Dudney, Jr., the residence is a one-story, five bay, frame variation of the late-Victorian Cottage plan and form, detailed with elements of the Colonial Revival style. The structure is covered with a complex hip and gable roof structure with a hipped gable and gable ends enclosed with a pent roof. The roof is covered with asphalt shingles.

The exterior of the structure features an L-shaped porch extending across its front, which is covered with a half-hip roof and supported by paired columns with Doric capitals on Tuscan shafts. Two entrances lead to the interior from the porch. The main entrance features a full leaded glass transom and sidelights around a single-light door. The side (eastern) door from the porch features a single-light transom above a single-light door.

The exterior of the structure is clad with weatherboard siding. Windows of the structure are one-over-one double-hung sash lights.

The interior of the structure is laid out in a variation of the traditional cottage plan. Public rooms of the house flow from one to another through large openings; the private spaces of the home are grouped around a partial center hall leading to the kitchen at the rear. A large informal living room space lies inside the front door, with a formal dining room beyond to one side, separated by a double, multi-light door. Both rooms feature fireplace mantels and trim details of the Colonial Revival period.

The dining room is notable for its mantel, which features a pair of shadow boxes detailed with Arts and Crafts fretwork, and for its trim features, which include a high plate rail and a cornice composed of an elongated cyma and picture mold. Beyond the dining room is a butler's pantry connecting it with the kitchen.

The bedrooms and other private spaces of the house are arranged on the eastern side of the plan, across the hall from the others. Each room is simply detailed. Enclosures of rear porches were made in the 1950s to provide an office space and a den space.

Associated with the Dudney House is a single-story frame carport and storage building, built in ca. 1950 with a hip roof and weatherboard siding. This structure does not contribute to the significance of the property.

The Jack Dudney House is significant under National Register Criterion C in the area of architecture as a significant local example of the Colonial Revival style. Built in 1911 for local merchant and politician Jack Dudney (1875-1954), the residence remains as a distinctive part of the residential and commercial construction boom in Collierville during the period ca. 1895 to 1920. The structure remains as a visible and notable part of the streetscape of West Poplar Avenue (State Highway 57), the major east/west transportation artery through this portion of Shelby County.

Born in 1875 in the town of Macon, Tennessee in nearby Fayette County, John Frank (Jack) Dudney, Jr. moved to Collierville with his mother and father in 1885 to establish his father's general store on the Collierville Town Square. Raised in the mercantile environment of his father's business, the younger Dudney entered the retail trade after completing high school as a clerk in the McDonald Brothers Mercantile Store, also on Collierville's Town Square.

Aside from his retail business interests, Dudney maintained a daily interest in a 600 acre family farm, like many other merchants in the town. The farm was run by overseers from its headquarters on Peterson Lake Road. The farm was assembled by Dudney's father from 1885 to ca. 1900, and its operation was continued by the family until dissembled by Dudney's estate following his death in 1954.

In about 1905, Dudney joined the grocery and dry goods company of W. J. Crenshaw of Collierville and rose to the position of partner. While employed there, Dudney acquired a tract on the old State Line Road (now West Poplar Avenue) and employed an unknown local builder to construct this house in 1911. It is suspected to be the work of prominent local builder W. W. McGinnis (1876-1959), though no evidence of this association has yet come to light for this particular property.

Following the construction of his home, Dudney joined with J. T. Biggs in 1914 to open a general merchandise and dry goods store under the name of Biggs and Dudney. During



the early part of the twentieth century, Biggs and Dudney served as a small department store of a sort for the retail needs of the growing Collierville area. While partner of this successful enterprise, Dudney entered the world of local politics with his election as magistrate of the County Court beginning in 1922. With the death of J. T. Biggs in 1935, the firm of Biggs and Dudney was disbanded. At this same time, Dudney was elected Chairman of the County Quarterly Court, a position he held until his death at his West Poplar Avenue home on April 2, 1954. Dudney's tenure as Chairman of the Shelby County Court lasted longer than any county elected official in the years before or since. The property is carefully maintained today by the son-in-law of Dudney, Thomas Dean, who first occupied the home in the 1930s with his wife, Eula Dudney Dean.

The Jack Dudney House stands as a significant element of the Town of Collierville as outlined and defined in the Multiple Resources Property Form for the Historical and Architectural Resources of Collierville, Tennessee. The property maintains aspects of integrity in the qualities of its design, materials, setting and workmanship as set forth for the evaluation of individually-eligible properties under Criteria C in the area of architecture. The property also reflects qualities of its historical association consistent with residences constructed during the Post-Bellum Development of Collierville in ca. 1866 to 1920.
