Introduction

The Carl Penke farm is a late 19th to early 20th century farm complex located in Douglas County near Bennington, Nebraska. The farmyard gently slopes toward a creek that flows into the Big Papillion River. While the immediate setting of the farmyard is rural, modern developmental pressure from nearby Omaha is present nearby. The nomination includes four contributing buildings: the house, a barn, a garage, and a chicken coop; two contributing structures, a root cellar and a corn crib; and one noncontributing structure: a modified chicken coop. The buildings and landscape associated with the farm are in an excellent state of preservation.

Description

The Carl Penke farm is located in rural Douglas County, Nebraska. Douglas County is located in the eastern portion of Nebraska and its eastern boundary is the Missouri River. The area of the nominated property can be characterized as gently rolling to hilly. As the crow flies, the Carl Penke farm is located approximately ³/₄ mile southwest of Bennington and is approximately 61 miles northeast of Lincoln, the state capital.

This farmhouse faces east and when approaching it from the west, remains largely unseen. The farmyard is accessed by a long drive off of a county road. The driveway curves slightly to the south as it approaches the house. The house and the root cellar are located on the south and west side of the driveway, while the remainder of the outbuildings flank the north and east sides of the driveway. The farmyard is well protected by windbreaks on both the north and west sides.

The large two-story frame farmhouse was constructed in 1910. The east facing façade is the primary façade of the house and it is this side of the house that provides a bit of architectural interest. Two small covered porches are present on either side of a two-story canted bay. The porch at the north end allows access into the kitchen while the porch at the south end opens into the formal parlor. The northern porch has a frame wall with a small fixed window turned on end to form a diamond shape. This porch wall undoubtedly helped to block the fierce north wind as one readied to enter the house. A 1910 photo shows that the eastern side of this porch was screened, but now this porch is open. The canted bay ends with a gabled dormer projecting from a hipped roof. The gable end of the dormer is decorated with patterned wood shingles. Each floor of the canted bay contains a fixed picture window with double hung windows on either side. Each picture window features a fixed transom decorated with etched or stained glass. A small fixed window is located on the first level of the house near the southern porch. This window features one larger pane of glass surrounded by smaller panes. The remaining facades of the house are simple, broken up only by double hung one over one windows. The hipped roof is covered with asphalt shingles. The only apparent exterior change is the addition of new French doors on the rear façade.

The interior floor plan of the house is simple and large square rooms flow easily into one another. The interior of the house retains original wooden floors and wooden trim details. Most of this wood detail is southern pine, though oak was used for the floors and trim work in the former formal parlor. Pocket doors are present between the dining room and the living room as well as between the dining room and the parlor. Door hardware and light fixtures are original. The kitchen has been sympathetically modernized. During this rehabilitation, an adjoining bathroom and pantry were remodeled into a single bathroom. Four bedrooms and a bathroom are located on the second floor.

The oldest building on this farm is the gable-roofed barn constructed sometime in the 1880's. The barn sits on a stone foundation and is clad with vertical board and batten siding. The barn is positioned on a north-south axis leaving the gable ends to face north and south. A single Dutch door allows access to the barn from the north side, and a small two over two fixed window is centered between the edge of the door frame and the eastern edge of the barn. The gable end of this northern face exhibits a one over one double hung window complete with screen. The west side of the barn is punctuated by a two over two fixed window at either end, two side-by-side double Dutch doors positioned slightly off center and a centered dormer entrance. The dormer features two additional side-by-side double Dutch doors that allow

access to the haymow. The eastern side of the barn contains three Dutch doors evenly spaced across the expanse of board and batten. A small gabled vent sits upon the crest of the roofline.

A small gabled wood clad structure located northwest of the house forms the sheltered entrance to the root cellar. This below ground root cellar is lined with bricks and retains the original hooks for hanging meat. Two chicken coops are located north of the root cellar and across the road. The westernmost chicken coop retains good physical integrity while the eastern coop has been repurposed and now has a modern door and modern windows. Positioned east of the chicken coops, a wooden corncrib now functions as extra storage and as a garage. The final outbuilding, a garage, is located east of the house. The garage is a one story gabled building clad with wooden siding. With the exception of one chicken coop described above, these outbuildings are all contributing resources in this nomination.

Taken as a collection of farm related resources, the integrity of the Carl Penke farm is excellent. Individually, the integrity of the farmhouse is high. The current owners have lovingly restored the outbuildings. Few alterations to the built environment have occurred on this farm. All seven aspects of integrity are well represented by the Carl Penke farm.

The Carl Penke farm is eligible for the National Register of Historic Places under Criterion A for its association with agriculture.

Carl Penke purchased his farm in June 1909. When he acquired the farm, a house was present, as was the barn described in Section 7. In order to accommodate his wife and five daughters comfortably, Penke began building a new house during the summer of 1910.¹ The existing house was moved to allow for construction of the current house. The first house was then given to a family that had lost their home in a tornado.² The barn was never enlarged or replaced.

Carl continued to farm until his death in 1936. Carl's widow, Lena, sold the farm to her daughter Clara Christensen and husband Elmer in 1947. The Sabus family has owned just over 10 acres of the original 80 acres since 1979.

Carl Penke began farming in Nebraska during a period of agricultural growth in Nebraska.³ Including the years 1880-1930, this period is described as the heart of the development of Nebraska's agriculture.⁴ By 1880, the initial settlement period had ended, and the now settled farmers have matured with their crops. It is during this period that most family farms are self-sufficient. Typically, a variety of crops were grown, along with livestock such as cattle and hogs. A large garden complimented the farm crops and livestock. Domesticated birds, such as chickens, ducks and geese provided eggs and an additional source of meat.

Having withstood the agricultural depression of the 1890's, the turn of the century brought renewed prosperity.⁵ On the Penke farm, the construction of the new 2-story farmhouse in 1910 is evidence of this prosperity. Following World War I, however, farm prices were low, and the nation was headed toward drought and the Great Depression.

The Carl Penke farm is significant at the local level under Criterion A. The farm retains an excellent collection of buildings representative of a broad pattern of agricultural development in Douglas County. The farmhouse and associated outbuildings retain a significant amount of physical integrity. Despite growing developmental pressure, the rural setting is intact and strengthens the feeling and association of this farmyard.

During the years that Carl Penke established this farm, the total number of farms in Nebraska reached its zenith. The number of farms held steady until the years encompassing the Great Depression.⁶ Since the Great Depression, the number of farms in Nebraska has been steadily declining⁷ and this decline continues to the present day. Douglas County is the location of Nebraska's largest metropolitan community, Omaha, and this translates into tremendous pressure for

continued urban expansion. The Carl Penke farm represents the family farm, a resource type that is growing increasingly rare in Douglas County.

In the 2000 census, for the first time in American history "farming" was not listed as a possible occupation. Less than two percent of Americans now engage in farming for a living. This small collection of buildings and the associated farm yard built and worked by Carl Penke represent a once ubiquitous and now rare piece of American culture: the family farm.

Verbal Boundary Description

That part of the north half of the southwest quarter of Section 15, Township 16 North, Range 11 East of the 6th P.M., Douglas County, Nebraska, and all more particularly described as follows: Beginning at a point 714.7 feet south of the northwest corner of the southwest quarter of said Section 15; thence north 85°33'east, a distance of 1500.6 feet to the iron pipe at the west bank of creek; thence continuing on same bearing east to center line of creek; thence south and southeasterly along center line of creek 800' more or less; to a point on the south line of the north half of said southwest quarter of Section 15; thence north half a distance of approximately 35 feet to an iron pipe on the west bank of said creek; thence continuing west along the south line of the north half of the southwest quarter for 272.9'; thence north 0°00' east on a line parallel the west line of said Section 15 for a distance of 497.5'; thence north 90°00' west on a line perpendicular to said west line of Section 15, a distance of 912.5' to west line of said Section 15, and center line of county road; thence north along said center line for 108.5 feet to the point of beginning.

Boundary Justification

As described above, the boundaries of this historic property include those buildings, structures and a portion of the land historically associated with the operations of the farmyard itself. These boundaries also coincide with the legal parcel owned by the current property owners.
