DESCRIPTION:

The Gustaf Anderson House is located on the east edge of the city of Lindstrom at 13045 Lake Blvd. The house faces north and is situated in a neighborhood of residences, commercial buildings, and churches. It is only a short block east of Lindstrom's central business district.

The ca.1879 two story red brick house is designed in the Italianate style. Characteristic features include the three bay front with a side hall plan, low hip roof, bracketted cornice, tall narrow windows set in segmental arched openings and decorated by ornamental brickwork, and two story bay window. A balconied entry portico supported by Roman Doric columns is located on the front facade. The simple classical lines of the portico suggest that it was added sometime after the house was built, although a balconied entry portico probably always existed at this location. A one room frame addition is located at the rear of the house.

The brick house is distinctive among the housing stock of the Chisago Lakes area both for its brick construction and close association with a high style design. It has been very well preserved and is presently being used to house a Real Estate business and lawyers' offices.

SIGNIFICANCE:

The Gustaf Anderson House is significant both for its locally notable Italianate style and for its association with a prominent Chisago County settler and successful speculator. The brick construction and local interpretation of the Italianate style make the house distinctive in a county where the housing stock is dominated by simple frame vernacular structures. The residences reflects the status achieved during the lifetime of its owner, Gustaf Anderson. Anderson immigrated to Minnesota from Sweden in 1864 and later engaged in gold speculation in Montana. He eventually returned to farm in Chisago County, and in 1879 built a brick residence in Lindstrom for his retirement. The house represents the moderate degree of success achievable by the settlers/speculators of the middle and late nineteenth century. Gustaf Anderson House
