Little Texas (c. 1840) is a one story frame dwelling in the French Creole style. It also displays Greek Revival decorative elements. The house faces the Mississippi River and stands in a rural setting on the eastern bank in St. James Parish near Paulina. Despite a very short move in 1928 and some interior renovations, the house's Creole features and National Register eligibility remain intact.

Characteristics of Creole architecture found in Little Texas include:

- 1) the fact that the house stands raised seven feet above grade on large, rectangular, stacked cypress blocks,
- 2) a Class III hipped roof whose knee-wall support system represents the last stage in the decline of the Norman truss roof,
- 3) a hand hewn mortised and pegged frame,
- 4) bousillage walls,
- 5) an unusual surviving original floorplan which displays the geometry associated with Creole architecture. The home is three rooms wide, and each of these rooms is equal in size. In addition, the building has a second range of equal sized rooms behind the first.
- 6) two sets of French doors on the facade,
- 7) a front gallery with exposed beaded ceiling beams,
- 8) exposed beaded ceiling beams in all six of the home's original rooms, and
- 9) one wraparound mantel.

Greek Revival decorative features found in Little Texas include:

- the main entrance, which features an eight light transom, five pane sidelights, reeded pilasters flanking the single door, and a Greek shoulder molding motif outlining the entire ensemble,
- simple Greek shoulder molding around the French doors which serve as the facade's secondary entrances,

- 3) an interior opening featuring five pane sidelights and the Greek shoulder molding motif. This opening connects the home's two center rooms.
- 4) simple Greek Revival mantels composed of smooth pilasters, molded bases and capitals, plain entablatures, and very plain mantel shelves, and
- 5) dormers featuring pilasters with molded bases and capitals.

Other features of interest in Little Texas include ceilings 10.5 feet tall, two single leaf interior plank doors constructed of battens, and batten shutters on the windows.

Alterations to Little Texas have occurred in several distinct stages. These changes are as follows:

- 1) A rear gallery was added sometime during the late nineteenth century.
- 2) A renovation project, largely on the interior, occurred in 1923-1925. The plastered bousillage walls were covered with five inch double beaded tongue and groove boards. Cabinet rooms were added to the rear gallery. The newly created loggia was screened. A modern French door was installed in the opening between the center rear room and the loggia. Formerly only shutters protected this opening. New flooring was installed, and an interior kitchen was created in the right rear room.
- 3) A 1928 levee setback necessitated that the house be rolled back. In the process a few of the cypress block piers were replaced by brick, which was then plastered over.
- 4) Later in the twentieth century the right rear <u>cabinet</u> was expanded to create a laundry and pantry, while the left <u>cabinet</u> was converted into a bathroom.

Although Little Texas has been moved a short distance, it stands on its original plantation and still faces the Mississippi River as it has since the 1840s. The house retains its original Creole architectural character, alterations notwithstanding. As a rare and old example of an architectural tradition which once dominated St. James Parish, Little Texas is a worthy candidate for National Register listing.

Little Texas is locally significant in the area of architecture because it is among a limited number of French Creole residences in St. James Parish, which once had many more examples. It is also among the oldest Creole homes in the parish and displays rare surviving construction techniques.

The 1858 Persac Map of the Mississippi River shows approximately 111 St. James Parish plantations identified by the names of their owners. In addition, the map depicts a large number of unnamed agricultural tracts. Because the Creoles were the dominant group to settle and develop the area before the Civil War, it is fair to assume that many of the houses on these plantations would have been in the Creole style. Thus, one can legitimately estimate that St. James Parish had a minimum of perhaps 150 Creole style houses in 1858. However, the Historic Structures Survey of the parish indicates that only about 31 Creole houses remain. Eighteen of these date from after 1870, leaving only thirteen to represent the parish's earlier Creole tradition. Little Texas is one of these. In addition, Little Texas is one of only nine Creole dwellings in the parish which use colombage construction (half timbering with infill) in their walls, and its stacked cypress block piers are a rare surviving example of this building technique.

#### Historical Note

Little Texas has belonged to descendants of the Brignac family since 1866, when the eight heirs of Pierre Brignac purchased it for \$3,800 at a public auction. Previously it had belonged to Francois Schexnayder. Shortly after the purchase Florian Brignac consolidated ownership of the property by buying out his co-owners. He then held the property until 1916, when he sold half to his son Charles and the other half to his son-in-law Charles Genre, who was married to Julie Brignac. In 1928, Charles Brignac sold his half of the property to his brother-in-law, making Charles Genre the sole owner. The current resident, Mrs. Marie Genre Donadieu, is the daughter of Charles and Julie Brignac Genre. She has lived in the home for much of her life.
