Description

The Stony Point Evangelical Lutheran Church (1882-1883) is located in rural Douglas County, KS, southwest of Vinland. The property sits at approximately 1575 N 600 Road on the NW 4, NE4, NW4, NE4, S. 20, T. 14, R. 20. Visible from N 600 Road, the church is accessed by a gravel land and is contained within a chain link fence and gate.

The church sits atop a dramatic valley, maintaining a western facade orientation. The site is treed with mature plantings. The cemetery stands to the south of the church, it contains thirty-five plots. The somewhat isolated and removed sitting of the church provides for a setting that has changed little over time.

The church measures 24' from north to south and 42' from east to west. The rectangular gable roof structure stands on a native limestone foundation. Its wood frame is sheathed with cedar lap siding. A composition roof installed in 2001 protects the building. In 2003 the asbestos tile siding applied in 1956 was removed and the original wood siding was repaired, primed and painted in 2005. A three step concrete platform leads up to the entry doorway. This modification occurred in 1901, replacing the original wooden porch.

Eight 4/4, double hung sash windows fenestrate the building. Three windows pierce the north and south elevations each, two windows fenestrate the western façade, framing the center door. The wooden, 4/4 paneled double entry door is surmounted by a three paned, fixed transom. Pedimented wooden lintels surmount the façade windows and center entry door. The windows measure $29 \frac{1}{2}$ wide by 84" high. The double door measures 47" wide by 7' high, the transom window measures 47" wide by 24" high.

The building retains an original interior appearance. A row of pews stands on either side of the center aisle, pews for the choir stand on the north side of the raised altar. The interior walls measure 11' high, the windows are 34" above the floor. Tongue-and-groove, wooden wainscoting lines the walls below the windows. A wood floor runs lengthwise. The plaster walls are finished with a coat of green Alabastone, which was applied in 1935.

A historic wood-frame outhouse, date of construction unknown, is located to the rear (east) of the church and is contributing to the nomination. The relatively large acreage also contains a cemetery that is historically associated with the church but is not part of the nomination.

Statement of Significance

Summary

The Stony Point Evangelical Lutheran Church (c. 1882-1883) is being nominated to the National Register under Criterion A for its historical association with the growth and development of the Stony Point community in Douglas County, KS, and under Criterion C for its architectural significance as an example of a late 19th century, gable front, one-room house of worship. The church served the worship needs of a large, extended family of Eberharts and Hemphills, as well as other Vinland-area families, until the early 1900s. Maintained by the Stony Point Evangelical Lutheran Church and Cemetery Association since 1898, the building is used primarily during Memorial Day.

History

Organized in 1860 as Christ's Evangelical Lutheran Church, the congregation was one of the first Lutheran denominations in Kansas. Led by Rev. David Earhart, the 24 charter member parish worshiped in the log cabin home of Joseph Eberhart. Earhart was the second Lutheran minister to preach in Kansas. He led the Christ's Evangelical Lutheran Church until 1868, and continued to work in Kansas until 1873.

Joseph and Catherine Kistler Eberhart emigrated from Pennsylvania to Kansas in 1854. Both had been born near Wurtemberg, Germany. The couple first settled in Pleasant Grove, Kansas and later bought land near Vinland from Jacob Branson. The Eberhart's produced 13 children, of whom most were actively involved with the Christ's Evangelical Lutheran Church. At least four generations of the extended Eberhart family is buried in the church cemetery.

Efforts to raise funds for the construction of a larger church dedicated solely to worship began with Rev. Earhart's departure. The church council appointed Joseph Eberhart to solicit and collect funds for a church in October 1868. Eberhart's sons Obediah and Lewis Jacob, and their brother-in-law Michael Heming were appointed by the council to secure land for the new church and cemetery. Obediah, the eldest son, and his wife Susanna deeded land for the church and cemetery to the congregation in 1873. Before Joseph Eberhart died in 1882 he had personally donated nearly \$200 to the church fund.

Under the leadership of Rev. Daniel Scholl, the congregation built a 24' x 42' frame structure from March through December 1882. Joseph Eberhart's sons Obediah, Henry, Lewis Jacob, Paul and Andrew, and their brother-in-law Isaac Hemphill spent these months hauling rock, sand lumber and lime. A mason from the Ottawa area was hired to lay the foundation, with Isaac Hemphill assisting. Presumably the framing, wood and plasterwork were accomplished by members of the congregation, including the Eberharts and the Hemphills.

Over a twelve-year period the congregation raised \$1,500 to cover the cost of materials and labor. An additional \$569 was raised to purchase a reed organ, which was installed in the church the day before its dedication.¹ Dedicated on November 18, 1883, Rev. Scholl wrote that, "This congregation built a very neat and substantial frame church, well furnished and in a good location." (*Lutheran Observer*, November 1883)

Rev. Scholl served the congregation from 1879 until 1898. Scholl ministered, baptized, eulogized and taught three generations of Eberharts. When he left the congregation both Joseph and Catherine and five of their children had passed away. In the succeeding nine years three more second generation Eberharts passed awy. By 1905 many of the congregation members had either died or moved away, eliminating the need for regular Sunday meetings. The congregation continued to be served by Lutheran ministers until 1902, and then after that by seminary students. Entries in church records show that communion was last offered in 1905, and that the church had twenty-five members in 1907.

While the Stony Point Evangelical Lutheran Church's active use spanned less than a twenty-five year period, it served its congregation during a time of great growth for the Lutheran Church in Kansas. In 1878 there were two Lutheran organizations in Douglas County, including 90 members. The smaller congregation was Christ's Evangelical Lutheran Church. Statewide the Lutheran Church boasted 4,560 members in 1878, by 1886 that number had grown to 11,651. In 1906, the Lutheran Church was the sixth largest denomination in Kansas, with a membership of 28,642.

Upon Rev. Scholl's departure as the minister of the Christ's Evangelical Lutheran Church, the Stony Point Evangelical Lutheran Church and Cemetery Association was formed. The association's incorporation in May 1898 also marks the time when the church changed its name to the Stony Point Evangelical Lutheran Church. The association was formed to care for both the church and cemetery and continues to function in that capacity.

After regular church services ceased, the Stony Point Evangelical Lutheran Church and Cemetery Association held its annual meetings at the church over the Memorial Day holiday. Minutes from these meetings contain information about replastering and painting interior walls in 1935, installing composition roofing and asbestos tile siding in 1956, erecting a chain link fence in 1968, constructing a stone gateway and hanging gates in 1975 and 1977, and painting the church's exterior in 1980. The church experienced a significant face-lift recently, a new roof was installed in 2001, the asbestos tile siding was removed in 2003, and the original wood siding was repaired, primed and painted in 2005.

¹ Offer to buy reed organ was considered by board of trustees in 1954. In 1974, the organ was loaned to Larry Craig family and sold to family in 1995 for \$600.

The association celebrated the 78th year anniversary of the congregation's founding and the 55th year anniversary of the church's dedication in 1938. Three members of the 1883 church choir were present. In 1940 the association considered loaning, renting or selling the Stony Point Evangelical Lutheran Church to the Vinland Methodists, whose church has burned. Association members agreed to loan the church to the Methodist congregation for one year. The 1956 association minutes contain discussion about removing or replacing the building but all later actions proved to dismiss that idea. Currently, the association's membership is comprised primarily of interested citizens rather than descendants of the original congregants.

Stony Point Evangelical Lutheran Church stands as a reminder of 19th century building technique. Its simple, rectangular form and gabled roof offer a straight-forward image of utilitarian design. Facing west, the church sits on a hilltop overlooking a dramatic valley. Set off from the road and accessible by a private, gated lane the church is a visible landmark from the west. Although there are some newer homes in and around the valley, the overall and immediate historic setting of the Stony Point Evangelical Lutheran Church remains.

Built of wood frame construction the wood sided structure stands on a limestone rock foundation. The rocks are random laid and tightly fitted. Taking advantage of the hillside perch, the builders used the natural slope of the land to build the western front of the church almost to grade. As the building progresses eastward more of the stone foundation is exposed. The carefully planed and set narrow, wooden clapboard suffered little during the last 120 years. It holds its new paint as if it were a new building.

The main decorative features of the building are its windows and door. Pedimented wooden lintels surmount the façade windows and center entry door. The gently subtle design of the lintels adds grace and character to the understated structure. In addition, the 4/4 paneled, double wooden entry doors and the large 4/4 double hung windows that fenestrate the building add to its attractive appearance.

Well lighted by its eight windows, the building retains an original interior appearance. A row of pews stands on either side of the center aisle, pews for the choir stand on the north side of the raised altar. Wooden wainscoting lines the walls below the windows. Finished with a coat of green Alabastone, the interior looks much as it did in 1936.

The gable fronted, single-room building is an archetypal form. Its simplicity of form and relatively modest cost allowed this type to be built often for 19^{th} century rural churches and country schools. With more than enough room for the 35 congregants who took communion in 1886, the 24' x 42' space offered functional and pleasing worship accommodations.

Verbal Boundary Description

The nominated property is located on the NW4, NE4, NW4, NE4, S. 20, T.14, R.20 in Douglas County, KS. The property sits at approximately 1575 N 600 Road, west of Vinland. The nominated property measures 44' from north to south and 62' from east to west. This tract contains the church and a 30' perimeter around the structure. The nominated property is contained within a larger tract. The structure is abutted to the south by a cemetery, to the north and east by trees, and to the west by open fields. Visible from N 600 Road, the church is accessed by a gravel lane and is contained within a chain link fence and gate.

Boundary Justification

The nominated church and outhouse are part of a larger tract that is historically associated with it. The cemetery that is historically associated with the church is not included as part of the nomination.
