Description

Columbian School is a one-story elementary school with a rectilinear plan, a reinforced concrete frame and a flat roof. Modestly ornamented in the Moderne Style, the building has walls consisting of a smooth textured brown brick veneer with concrete capped parapets. The recessed front entry is located at the middle of a slightly stepped facade. Located behind the central portion of the building is a gymnasium/auditorium. A strip parking lot for teachers is located in front of the building on N. 2nd Street with residences lining the opposite side of the street. A playground extends behind the building. In 1950, additions were made at the southwest and northwest corners of the building, and in 1970 an addition was made at the northeast corner of the building. The additions, however, do not appreciably alter the historic appearance of the building's facade nor detract from its feeling as a New Deal property.

Although the original symmetrical facade of Columbian School was altered with the addition to the building's northern wing, the building conveys an appearance similar to when it was completed in 1939. Three classrooms, each marked by a grouping of five 1/1 double-hung aluminum windows with a fixed yellow-brown panel above and with projecting brick sills, flank the building's main entry to the south, and three flank it to the north. Recessed entries with double doors and small, slightly raised concrete porches lie at the end of both wings. A portal extends from the rear of the north wing to the classroom wing lying to the west. The main entry, consisting of double doors beneath a concrete lintel, is recessed with a slight infill of the previous portal on either side. Flanking it are two office spaces with roofs stepped slightly below the main roof line and with curved walls marked by four vertical fixed windows. Accessible from the foyer where the entry intersects the main corridor, these spaces house the nurse and principal's office.

The school's floor plan is consistent with the design used in schools built as New Deal projects in many New Mexico locales. It includes a central corridor flanked by classrooms. In back of the central portion of the building is a combination gymnasium/

auditorium. The square brick chimney on the north side of the gymnasium marks the location of the school's mechanical room.

Columbian School is in excellent condition and, with its additions sympathetic to the original materials and plans of the building, continues to convey the feeling of a New Deal project. Raton voters approved a bond issue in 1994 that will permit renovation of the school's heating and electrical systems and the renovation of bathrooms while retaining the historical integrity of the building.

Statement of Significance

Columbian School, a WPA project undertaken and completed in 1939, was one of several school projects completed in Raton by the New Deal. Made possible as a part of the federal government's efforts to stimulate the nation's depressed economy through a massive public works program, the school is a good example of how the New Deal's public works projects affected the welfare of a local community by creating much-needed jobs. The project also resulted in bringing much-needed improvement to the community's educational facilities. It is eligible under Criterion A for its association with Raton's social history and education during the New Deal. Columbian School is also eligible under Criterion C as a good example of the plans, methods of construction, materials and workmanship New Deal projects employed in carrying out hundreds of school construction projects in New Mexico.

Despite the loss of jobs that the Depression had brought to Raton's principle industries, the coal mines and the railroad, the town had continued to grow and, by the 1930s, found that its two grade schools, Longfellow and Columbian Schools, both built in 1906, were overcrowded even with additions made to both buildings in 1923. The town's leaders actively pursued school construction projects seeing new schools as creating construction jobs and relieving the schools system's chronic overcrowding.

After receiving grants for two PWA school projects in 1936 and 1938, Raton was authorized to construct two additional grade schools under WPA projects funded in July and November of 1938. The former, a \$53,000 appropriation, was for construction of a new Columbian School and the latter, a \$50,000 appropriation, was for the construction of a new Longfellow School. As these projects got under way, the Raton Range noted that the town's monthly WPA payroll was at least \$18,000, a considerable boon to its depressed economy.

Work began on Columbian School in January, 1939 with two shifts of workers totalling fifty men supervised by WPA foreman Burt Zimmerman. Some of the materials for the construction came from salvage recovered at the old Raton High School. With the foundation being laid in the cold of winter, Zimmerman devised a method to prevent the freshly laid concrete from freezing by wrapping pipes heated by a steam boiler around the concrete. By September, 1939 the school was ready to welcome students even though not all of the work had been completed. With four new schools, Raton's enrollment increased prompting E.E. Harrison, the school superintendent, to observe that many rural families were moving to the city "to give their children the advantage of the new buildings."

The plans for Columbian School were prepared by Willard C. Kruger, the state's WPA architect who had grown up in Raton, and Kenneth S. Clark, who worked with Kruger on the WPA staff and, in 1938, opened a practice with him. While it is unclear to what degree the architects' designs were influenced by local preferences, the <u>Raton Range</u> noted on February, 1939 that a local citizens group had requested that the veneer of the school be changed from stucco to brick, a change the committee viewed as an "improvement." The building's plans are similar to plans Kruger and his staff prepared for other schools around the state. Noteworthy of these plans were the standard classrooms flanking a central corridor design with a small gymnasium/auditorium attached to the rear of the building. As with these other school projects, the introduction of large windows providing natural

light, indoor plumbing, ventilation, heating system, and fire safety features such as outward-swinging double doors contributed to the modernization of Raton's schools.

Typical of other WPA projects, the Columbian School project was labor-intensive. Its extensive use of masonry including the curved walls, protruding sills, and concrete parapet coping furnish a good example of the workmanship and materials that marked New Mexico's New Deal schools.


