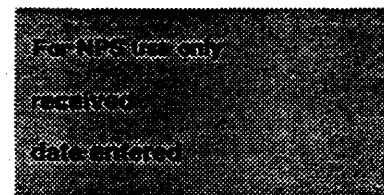

1. Name: Luciana B. Grijalva House, survey number 54
2. Location: approximately 4/10 of a mile east of Highway 61 and 1.5 miles north of the San Lorenzo turn-off
4. Owner: John Justus (Von Tress Estate), Box 38, Peralta, N.M. 87042
7. Description: Photo 41; single file plan with front shed-roofed addition; concrete foundation skirt, no foundation; stuccoed adobe (original section) clapboard (addition); hipped roof with gablets (original section) flat earthen roof beneath; 2/2 double hung and wooden sliding windows. Interior: wooden floors over adobe, beaded tongue and groove ceiling.
8. Significance: The original, single-file section of the house was built before 1912 as a traditional flat-roofed adobe structure. The front addition was added in 1918 and the pitched roof at that time or before. The house is a very good example of the New Mexico Vernacular tradition and how it evolved in the early 20th Century, and therefor meets Criterion C.
10. Geographical Data: Approximate Acreage: less than one.

Verbal boundary: A rectangle, roughly 60' by 40', formed by lines parallel to and ten feet from the exterior walls of the building. Since this is an unplatted area, this boundary has been created to include only the house.
