NARRATIVE DESCRIPTION

The Tubercular Cabin at the Cave Creek Museum is a small, one room, wooden cabin that was originally used to house a patient suffering from tuberculosis. It was probably constructed in 1919 or 1920, as it was one of fourteen cabins that comprised the "Desmont Sanatorium" that operated from 1920 until 1929 In Cave Creek, Arizona .It was relocated approximately one mile to its present location on the grounds of the Cave Creek Museum in 1984 to prevent its destruction. It now sits near the northwest corner of the museum property. The cabin's present high desert setting is nearly identical to its original historic location.

It is small, only 10'2" by 12'2" and of very lightweight construction. The wood frame floor now rests on a concrete slab but most likely, originally on a gravel bed, much like a tent. Wooden 2x4 interior framing is used to support the windows, door, and roof. The vertical bead siding is also partially supported by the framing, however there are no studs in the building corners, the siding being simply nailed to it's adjoining piece. The gabled roof is supported by 2x4 rafters which are covered with 1x10 pine boards and roll roofing. The rafters are tied with light chain to withstand outward thrust. Awning sashes covered with canvas light the building on three sides. The openings are screened on the inside. The door is louvered.

The building is not served by electricity, gas, water, or sewer, however there are interior "ghost markings" which mark the location of a small corner "dry" sink and small stove. The rear of the building shows repair of the holes where the sink drain and stove pipe chimney exited the building. There are no interior walls or ceiling and the interior is not painted.

The roll roofing is recent, most likely replaced in 1989 or 1990. The exterior was repainted in 1999 and the canvas on the windows replaced at that time.

The building is well maintained and in good to fair original condition.

NARRATIVE STATEMENT OF SIGNIFICANCE

The Tubercular Cabin at the Cave Creek Museum is significant as a Criteria Consideration B (moved property) structure because it is a distinctive building design and type important to the development of Arizona and the Southwest United States. It is a small lightly constructed building used to provide isolated housing for patients suffering from tuberculosis. Its light (handy-man type) construction and very unique framing techniques point to its evolution from a tent. "Tent Houses" were a form of housing for many uses in territorial Arizona. Hundreds of these cabins were located in Arizona but apparently no others have survived. The one other known Tubercular Cabin is of much more recent and modern construction and is located in the courtyard of a hospital. The sparseness of this building demonstrates the bleak existence of those who occupied it and others like it, however many of these sturdy people overcame their afflictions and were pivotal in the development of Arizona and the Southwest. Although the cabin has been moved to prevent its destruction, it retains its character and is in nearly original condition. The Tubercular Cabin at the Cave Creek Museum deserves to be placed on The National Register of Historic Places.

Historical background and significance.

The treatment of persons with tuberculosis and other respiratory diseases is of great significance to the Cave Creek area of Arizona, the State of Arizona and the Southwest. In the nineteenth and early twentieth centuries tuberculosis was widespread in the United States. The only known treatment for the disease prior to the late 1940s was exposure to warm, light, dry, clean air. The climate of Arizona was ideal for these people, many of whom came to Arizona for treatment. In addition many persons suffering from other respiratory problems such as asthma, etc. came to alleviate their conditions. Many of the ranchers, cowboys, miners, business people, and ladies of early Arizona migrated here because the climate was beneficial to their respiratory problems. Many regained their health and became the pioneers, leaders and legends of the Southwest.

Because it is highly contagious, tuberculosis patients were usually isolated from the rest of society in sanitariums. Beginning in the first decade of the 1900s when Arizona was still a territory, and until the 1940s there were many respiratory treatment facilities in Arizona. The first known in the Cave Creek area was in 1907. It was a small tent facility at the "Howard

Ranch" however the neighboring ranchers were very unhappy to have persons with a highly communicable disease in their midst and the facility soon closed.

The first sanitariums in Arizona generally used tents to isolate their infectious patients. These were very hot in the summer, without floors, which allowed easy access to scorpions, snakes and other pests, and lacked good ventilation which was essential to the patient's treatment. Soon, floors and windows were placed in tents and many styles of cottage or cabin evolved. The most common was the small, lightly constructed one room cabin approximately 10 by 12 feet in dimension covered with canvas or wood. A number of these were often clustered around central sanitary and dining facilities.

The Tubercular Cabin at the Cave Creek Museum is typical of the hundreds in use in the 1920s and 1930s and one of the very few remaining. It was one of fourteen cabins clustered around a central dining area and sanitary facility which comprised the "Desmont Sanitarium" located near the present site of the "Le Sans Souci" restaurant on the south side of Cave Creek Road in the Town of Cave Creek, Arizona. The sanitarium was owned by Sam and Helen Jones, and operated from 1920 until 1929. Low occupancy brought about by the great depression forced the closure and subsequent sale. Exact ownership for a number of years is unknown, however the cabin was most likely used as housing for the transient workers employed in the construction of t Bartlett Dam on the nearby Verde River from 1930 till 1938. In the 1930 s the cabin was moved to a site on the north side of Cave Creek Road near the location of what is now the Horny Toad Restaurant.

In the late 1930s or early 1940s it was acquired by Ms. Dixie Nissan who used it as part of an "Inn" and restaurant named "The Mustache Cup". The cabin was reputed to have been used by prostitutes at the inn to entertain their clients.

In 1945, Ms Nissan gave the land and cabin to Mr. Santos Rubira who used it first as a residence and later as a vacation cabin. In 1984, Mr. Rubira resold the land and donated this, the last remaining Tubercular Cabin to the area to the Cave Creek Museum for historic preservation. It has been preserved and on display at the Museum grounds since that time.
