#### DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

The Laverty-Martindale House is a two-story clapboarded structure of Italianate design. A veranda wraps around the front and sides of the house. The supports consist of paired pencil-thin columns on high, blocky pedestals with an eave bracket over each column. Thin corner pilasters frame the front (west) facade which features a large, simple, double door with rectangular transom, and two floor-to-ceiling windows on the first floor. The window lintels are supported by small brackets. Double eave brackets with pendants decorate the entablature. A rectangular cupola surmounts the shallow-pitched hip roof. The cupola has an arcade of three round-arched windows on Doric piers on the front and four on each side with single eave brackets enriching the entablature. A low, hipped roof covers the two-story back wing.

The first substantial rise in the property tax for the two lots on which the Laverty-Martindale House is located occurred in 1861. Therefore, the house had probably been erected by that time. The contract with the builders, Richard Moffatt and Son, was cancelled in 1863. However, in 1868, when the Martindales were negotiating to buy the house, the front part of the second floor was not yet completed. The first floor plan is typical of the period. Front and back parlors along the south side of the house parallel a long hall (with curved staircase) along the north side which leads to the dining room. The kitchen (behind the dining room) and the master bedroom (behind the back parlor) are separated by the service stairs and a pantry. To the east of the kitchen is the rear shed which housed a workshop, the water closet, and the cistern. The outside walls of the parlors are twelve inches thick to accommodate disappearing blinds on the windows and round-arched niches flanking the fireplace in the north parlor. This simply carved, marble fireplace is the only original mantel extant in the house. A built-in breakfront with glass doors above and cupboards below graces the west wall of the old dining room.

In 1883-1884, the north wing was extended five feet north. A brick chimney and fire-place flanked by French windows was added to the dining room which after 1906 became the library (the old master bedroom was converted into the dining room). A "modern marbleized mantel" decorated the second floor fireplace in the new wing. The Martindale's son, Stephen IV, lived in this bedroom until his first child was born in 1888.

After Stephen Martindale III and his wife died in the winter of 1905-1906, the house was modernized. A sleeping porch was added above the east entry porch and dormers were added onto the rear shed; central heating, a modern bathroom, and electric lighting replaced the old stoves, water closet, and gas lights. The fruit cellar in the basement was converted into a laundry. The partition between the front and back parlors, includin its sliding doors, was removed and the woodwork in the upstairs bedroom was painted white (the rest of the woodwork retains its dark stain and hand graining). Since these alterations, no significant changes in the character of the house have occurred.

The house is painted colonial yellow with white trim, green blinds, and red doors as a picturesque allusion to the autumn color of hard-maple trees in New England.<sup>4</sup> A two-story, frame barn sits to the northeast of the house. It was built in 1886 to house a storeroom, and a studio for a daughter who was an artist.<sup>5</sup> A wooden fence, built in 1972 and similar to the 19th century fence, encloses the lot.

#### STATEMENT OF SIGNIFICANCE

The Laverty-Martindale House is significant architecturally as a fine, relatively unaltered example of the frame Italianate house and historically as the home of early settlers of La Crosse and prominent businessmen in the early history of the area.

In his discussion of the origins of Percy Dwight Bentley's early Prairie School houses, H. Allen Brooks uses the "four-square" Laverty-Martindale House as "a splendid example of the type of residential construction being done in the mid-nineteenth century."

On December 27, 1859 Richard Moffatt and Son (Richard R. Moffatt) contracted with Thomas and Maria Laverty to build a house for them. Cash payments were to be made as work progressed over sixty weeks with a transfer of five acres of land when the work was complete. The Moffatts were English emigrants who called themselves "mechanics."<sup>2</sup>

Thomas Laverty was a sailor from New Brunswick. He moved to New York where he married his wife Maria before moving on to Milwaukee in the late 1840's and then to La Crosse. In 1859 he was renting a store in La Crosse from I. Munson Hill, Stephen Martindale's brother-in-law, who lived in Beloit at the time. Laverty enlisted in the Union Army on April 18, 1861 and returned home a disabled veteran in August, 1863. On November 11, 1868 the Lavertys sold their house and shortly thereafter returned to the east.

Stephen Martindale III, his wife, Katharine Howard Martindale, and their children were the next occupants of the house. In 1849 Stephen Martindale III went west to Racine from his home in Wallingford, Vermont after graduating from Middlebury College and the National Law School in New York. In Racine he worked for his brother-in-law's lumber firm, Durand and Hill. Five years later he came to La Crosse. He formed a business partnership with Albert W. Pettibone and the two men built a double house together. Then Martindale returned to Vermont to claim his bride. Martindale and his partner pursued several business interests. In the late 1850's they owned a mill in Black River Falls. In the Civil War Martindale served as a colonel and aide-de-camp for the Union Army. In the 1880's he bought the G. R. Montague Agency of Northwest Mutual Life and devoted his time thereafter to insurance and loans.

Meanwhile his son, Stephen IV (b. August 21, 1859) had married Sophie Rosenblatt whom he met at Beloit College in 1883 and received his law degree at the University of Wisconsin in 1886. He practiced law in La Crosse for five years and then joined his father in business after he had stepped in to help and found it to his liking. In 1906, after the elder Martindales had died, Stephen IV moved his wife and three children into the family home. His daughter, Katharine, continued in the insurance business and still resides in the Laverty-Martindale house.
