SUMMARY

The Church of the Immaculate Conception, located at 121 East Duval Street, in the downtown area of Jacksonville, Florida, is a large, two-story, Late Gothic Revival building with a limestone exterior, elaborate traceried fenestration, and two spired towers. The vaulted interior also displays a great deal of Late Gothic architectural detail. The Church of the Immaculate Conception is the oldest Catholic congregation in Jacksonville, and one of two Late Gothic Revival churches in the downtown area. The ediface, built between 1907 and 1910, is one of the finest examples of Late Gothic Revival church architecture in Florida. The church contributes to the Historic Buildings of Downtown Jacksonville multiple property group under associated property type F.6, Historic Religious Buildings of Downtown Jacksonville, 1901-1927.

PRESENT AND ORIGINAL APPEARANCE

Setting

The Church of the Immaculate Conception is located on the onehundred block of East Duval Street occupies lot 1 of block 26H in the Jax Harts Map Subdivision, Jacksonville, Florida. With its north facade fronting Duval Street, the building is a landmark surrounded by tall masonry buildings.

Present Appearance

The Church of the Immaculate Conception exhibits a high degree of architectural ornamentation. General attributes of this Late Gothic Revival church are embodied in its cruciform groundplan, rough-faced Kentucky limestone exterior, carved stone detailing, and its lancet window and door openings used throughout the building. The south elevation is framed by a pair of polygonal spires that tower above the ridge of the steeply pitched frontfacing gable roof (Photo 1). The spires, one taller than the other, are topped by gold plated crosses. The west tower has a square base which rises to a belfry with louvered openings, and is finished with carved stone cornice detailing (Photo 2). The east tower is accentuated with an open belfry with carved stone pinnacles, tracery, and lancet openings (Photo 3). A grand lancet window with traceries and stained glass is centered in the front-facing gable end. Directly above it is a stone statue of the Virgin Mary and a carved stone cross at the

gable peak (Photo 4). The center and west tower entrances, both of which are recessed, have carved lancet surrounds with traceries and pinnacles (Photo 5). Strips of lancet windows flank the main entrance. Visible from the street are the transepts, located toward the rear of the building.

The <u>west elevation</u> is comprised of the bell tower, nave vestibule, a trancept, the apse, sacristy, and vestibule. The bell tower has a lancet window located at the second story stair landing. A series of full height lancet windows finished with traceries and stained glass light the nave (Photo 6). Clerestory stained glass lancet windows, located just above the nave roof, rise to small cross gable structures (Photo 7). These windows cast light down onto the nave. Each of the cross gable structures is topped by a carved stone pinnacle. The projecting transept has a grand lancet window finished with stained glass and traceries. The sacristy has a hip roof and lancet window. A clerestory window is located just above the roof of the sacristy. The apse has a hip roof and a full-height lancet window. The vestibule has a one-story flat roof and small lancet windows.

The north elevation consists of an apse, the east and west transepts, the east and west sacristies, and a one-story vestibule which serves as an access to the altar and sacristies from the north (Photo 8). The semi-octagonal apse has three full-height lancet windows finished with stained glass. The sacristies, which flank the apse have hip roofs and lancet windows. A pair of chimneys, which ascend from the sacristy roofs, rise well above the eave line. The vestibule has a flat roof and is lighted by small lancet windows.

The <u>east elevation</u> has fenestration very similar to that of the west elevation. The first story has full-height lancet windows finished with traceries and stained glass which light the east nave (Photo 9). Clerestory stained glass lancet windows located just above the nave roof cast light into the central nave. The clerestory windows terminate in a small cross gable structure topped by a carved stone pinnacle. The west transept, which dominates the facade, has a grand lancet window with stained glass and traceries. A stone cross is located at the peak of the transept gable end.

Interior

Patrons enter the church through two doorways that open onto East Duval Street. The entrance foyer is carpeted. The walls exhibit fine gothic woodwork fashioned out of oak with a natural finish. A stair case in the west bell tower leads to the choir area and balcony (Photo 10). The stair is also constructed of oak and its balustrade and newel post display elegant gothic detailing. A second flight of stairs leads to the belfry and steeple.

A colonnade of traceried piers divides the sanctuary floor into the central nave and side aisles. The nave has a full-height vaulted ceiling with traceries that originate in the slender nave piers (Photo 11). Rosette skylights, located at the terminus of each ceiling vault, cast natural light into the nave. The south end of the nave has a balcony where the choir and pipe organ are located. The confessional booths are located directly below the balcony. Wooden pews line the center aisle of the nave. The floor is planked with tongue-and-groove oak. Other features include cast angels and statues of biblical figures all of which are painted in pastel colors (Photo 12). Painted-on design motifs are located near the pier capitals on the ceiling.

The east and west side aisles have wooden pews (Photo 13). The walls are embellished with full-height stained glass windows depicting biblical scenes. A series of molded reliefs depicting biblical events are attached to the exterior walls between each stained glass window (Photo 14).

The wooden pews of the central nave and side aisles extend into the east and west transepts. Grand stained glass windows at the end of each trancept cast light into the crossing (Photos 15 & 16). High above the main floor, the trancept is lined with trumpeting angels where the walls begin to arch into the ceiling (Photo 17). Secondary exits, located at the south wall of each transept, provide egress.

Two altars, located in the apse, are separated from the transept by an ornately carved marble communion rail (Photo 18). A simple marble altar is located in the apse and a more ornate altar is located behind it (Photo 19).

SUMMARY

The Church of the Immaculate Conception is one of seven churches constructed in downtown Jacksonville between 1903 and 1910. The church was designed by architect M.H. Hubbard and constructed by the Halsema-Woodcock Company. The Church of the Immaculate Conception is one of four Late Gothic Revival buildings constructed in downtown Jacksonville in the wake of the Great Fire of 1901. The church is significant under National Register Criterion C, at the local level, as one of the finest examples of Late Gothic Revival architecture in Florida. It contributes to the Historic Buildings of Downtown Jacksonville under historic context, Jacksonville Renaissance, 1901-1920 and associated property type F.6, Historic Religious Buildings of Downtown Jacksonville, 1901-1927.

HISTORICAL CONTEXT

The Church of the Immaculate Conception was initially organized in 1829 as a mission of the Catholic parish in Savannah, Georgia. Two buildings were constructed prior to the present edifice. The first building, constructed in 1847, was burned by Federal troops during the Civil War. The Great Fire of 1901 engulfed the second building which was completed in 1874. Under the leadership of Father Michael Maher, pastor of the church from 1902 until his death in 1925, the present church was built. Funds for the new building were raised within the Catholic Church on a national basis. The present building, constructed of roughfaced Kentucky limestone block, with carved limestone detailing, and stained glass windows, was constructed at a cost of \$160,000. Finished in 1910, additional touches were added until 1913. In 1979, it was "solemnly dedicated," meaning that it can never be purposefully demolished or used for any other purpose than a church, a distinction held by few Catholic churches.

ARCHITECTURAL SIGNIFICANCE

Architect M.H. Hubbard, designed the Church of the Immaculate Conception in 1905. A year earlier, his plans for the Colonial Revival style Bethel Baptist Church, located at 1058 North Hogan Street, were completed. The Halsema-Woodcock Company, serving as builder, laid the foundation in 1907 and completed it in 1910. Dedicated in 1910, it took three more years to conclude the finishing touches. Hubbard, a native of

Utica, New York, came to Jacksonville as many other architects did, in search of work after the Great Fire. Whether Hubbard stayed in Jacksonville or not needs to be documented.

Its tall spires, lancet windows, traceries, stained glass, rough faced limestone exterior, and interior detailing, distinguish the Church of the Immaculate Conception as one of the finest examples of Gothic architecture in Florida. The Gothic style was most popular in the United States between 1840 and 1870, although it remained a popular design for religious and educational buildings well into the twentieth century. Andrew Jackson Downing is said to have built the first example in America in 1832. The twentieth century variety of the gothic style is termed Late Gothic Revival because of its resurgence in popularity distinct from the period ending in the 1870s. vertical nature of the style, characterized by pointed arches, traceried windows, pinnacles, slender piers, panelled stonework and the lofty steeple, is symbolic of a soaring ascent toward the These attributes are especially adaptable to church architecture.

Downtown Jacksonville boasts five examples of the Gothic style which fall in two classifications. St. Johns Episcopal Cathedral, located at the corner of East Duval and North Market Streets, Old Duval County Armory, located at 851 North Market Street, and Snyder Memorial Methodist Church, located at 226 North Laura Street, are Tudor Gothic. The others, classified as Late Gothic Revival, include the Taliferro Memorial Building, and the Church of the Immaculate Conception. The Tudor form uses the horizontally oriented crenelated parapet with battlements in place of lofty spires, evoking less emphasis on verticality.






