Built as a 28x40 ft. bungalow with 6 rooms and a half basement, this house now has 6 rooms on each of the two stories and an enlarged base-The exterior is one-half siding on sheathing and one-half wood ment. shingles. The gable roof is covered with composite shingles. Two roof dormers with casement windows face south. That side also includes a covered open porch below with two picture windows split by a wood door with sidelights and three narrow fixed windows and a 7-pane doublehung The east side has two doublehung windows on each of the stories window. and a basement window. The west side features two 9-pane doublehung windows, a fixed window, and three 7-pane doublehung windows all on the first floor. A wood stairway leads up to a second floor landing, which has a door splitting two doublehung windows. The north side includes a doublehung window, a porch and attached carport, an entrance, anothr doublehung window, and three 9-pane doublehung windows. The carport was built in 1960. A brick stack is located on the north side of the E-U gable. The east wall includes a modern one-and-a-half stack chimney. The interior includes high ceilings, built in wall cabinets with cames, interior double doors, and a window seat on the south side. floor has been remodeled into an apartment. The second

HISTORICAL INFORMATION: Describe the persons, important events, and/or historical patterns associated with the structure/site and surrounding area.

Claude W. Griffen arrived in Thompson Falls in 1911 to head the U.S. Forest Service operations here. He held the position of Supervisor to the Cabinet National Forest till 1916-17. Griffen's family sold the property in 1942 to Orin Kendall. Kendall served 22 years as the County Superintendent of Schools from 1946-1968, after which he served several terms in the state legislature. He also was mayor of Thompson Falls and served on the town council. He died in 1982.

It can not be dated with certainty when the twin dormers were built, but they do show in a Montana Power photograph of 1915 so they are probably original. The south side picture windows date from the 1970s, replacing doublehung windows. The west stairway, east wall chimney, and north side carport are all new. The upstairs interior and parts of the exterior have been remodeled. The first floor interior retains

The Griffen House is significant under Criterion C as an excellent example of a large Bungalow style house. The $1\frac{1}{2}$ story dwelling is typical of a "pattern book" Bungalow house and exhibits several architectural characteristics common to the style including exposed rafter ends, oversized brackets under a gable roof, narrow lap siding and wood shingles, and a large, full width front porch. The west side of Thompson Falls, where the Griffen House is located, grew most rapidly during the town's first substantial period of growth from 1905-1916. One of the most popular building styles in Thompson Falls from this era was the Bungalow, which gained enormous popularity throughout the country from the turn of the century until 1920. The Griffen House, which was built by Walter McCurdy, a carpenter who also served briefly as a town alderman, has been slightly altered but remains one of the best preserved examples of residential construction in Thompson Falls from the early 1900s.
