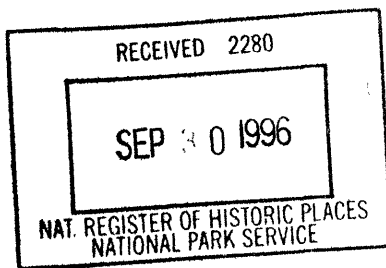

A detailed description of the physical characteristics of the stone is given in the Boundary Markers of the Original District of Columbia Multiple Documentation Form.

Intermediate boundary marker Southeast #1 is located in open space approximately 30 feet south of the intersection of Southern Avenue and D Street, S.E. The sandstone marker is in good condition. A 3' x 3' x 5' iron fence, also in good condition, surrounds the marker.

Southeast boundary stone #1 was the eighteenth marker to be located in Maryland. It was laid in 1792. Its fence was dedicated by the Sarah Franklin Chapter of the Daughters of the American Revolution c. 1916.
