DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

The Levy Brothers Building, designed by the firm of Clarke and Loomis, is located on the northeast corner of Third and Market Streets in Louisville (see photo 1). Occupying a prominent downtown site, its location is two blocks south of the Ohio River and three blocks northeast of the Jefferson County Courthouse and the Louisville City Hall Complex (listed on the National Register April 10, 1972 and September 1, 1976, respectively).

This five-story building is constructed of red smooth-faced sandstone. A six-story pyramidal slate-roofed tower that originally held an elevator occupies the corner position and provides the pivoting point for sections extending north and east. Above the first-floor level, details and openings remain intact, including two major round-arched bay windows having a height of two floors (see photo 2).

Though much of the building's terracotta detail has the overwrought quality attributed to the French Renaissance in the late 19th century, the final design is more discreet than a version shown in a lavish perspective drawing in the 1895 brochure, "Louisville of Today." "As erected, the structure has considerable dignity as well as display for many years the arches, balconies, windows, were framed by bright electric lights at night7, and the reddish-yellow brick and terracotta provides an appealing contrast to the colder grey limestone and pale yellow brick of much downtown [Louisville] construction."¹

The annex which extends from the north arm of the original building completed in 1893 was begun by the Louisville firm of Joseph and Joseph in 1913. Designed in the same style and employing the same materials, this addition is well integrated with the initial store. With the exception of first-floor modifications, such as the covering of bullseyes and the addition of cast-iron grillwork (see photos 3 and 4), the Levy Brothers Building's exterior remains essentially as designed. The interior has been considerably altered to accommodate present day retail practice.

STATEMENT OF SIGNIFICANCE

The Levy Brothers Building, located in downtown Louisville, remains as one of Louisville's finest examples in the city of sandstone construction, Richardsonian-Romanesque design, and commercial investment. Designed by C. J. Clarke and Arthur Loomis, the red sandstone structure creates a strong physical landmark; its tower is a pivot at the intersection of two downtown streets.

In their design for Levy Brothers, Clarke and Loomis tried their hand at deviating from the standard Richardsonian style of most of their work in the 1890s. The new building was completed in 1893, though enlarged later. The newspaper account of the opening states that the design is of "no particular style of architecture, but in detail what may be called French Renaissance." Actually, the profile of the tower, which turns the corner so effectively, the combination of square-headed and roundarched windows, and the delicate, open treatment of the street level shop windows are all reminiscent of the Chicago School.

The owners, Moses and Henry Levy were originally from Germany. Moses Levy emigrated in 1857 from Nierstein, Germany, to the United States, to be followed fifteen years later in 1872 by his younger brother Henry. In 1861 Moses opened a store known as "Levy, The Clothier," which in 1866, moved to the northeast corner of Third and Market Streets--the present location of the firm. Henry joined his brother in business about a year after his immigration into America, and the store has been continuously run by the Levys, now aided by the fourth generation, since its inception.

The old building was razed on June 14, 1892 and the Levy brothers opened their new building on September 28, 1895 with a magnificent party whose "floral designs" and music attracted "many from a distance in the county all over the State."

Years later hundreds of incandesent lights were added to exterior and display areas from which comes the (now archaic) local expression, "Lit up like Levy's." Another custom of the store was to send a pair of "pants" (about the size of one's hand) to many newborns in the city with a letter stating: "...When he shall gave outgrown these we shall be glad to have him call on us for another pair...."







Both the Levy brothers were active in their community. Moses was a director of the Cleveland Orphan Asylum, a member of the Board of Trade, The Commercial Club, the Standard Club, and others; Henry was a member of the Board of Trade, a director of the Commercial Club, vice-president of the Standard Club, Chairman of the Building Committee of the Young Hebrew Men's Association, and a Trustee of Temple Adas Israel.

Verbal Boundary Description




