STATEMENT OF SIGNIFICANCE

Documented as the design of Levi Weeks, Auburn was, by his statement, the first house in Mississippi Territory to employ the orders of Architecture. The temple form of the portico was so early and so influential that Auburn must be regarded as one of the most important houses in the South. Although the interior detail is Georgian and no longer fashionable in 1812, the woodwork is so well detailed that it commands admiration.

Auburn had two owners of distinction. Judge Lyman Harding, the first owner, was the first Attorney General of Mississippi. After his death in 1820 the property was acquired by Dr. Stephen Duncan. Though possessing a fortune in slaves, Dr. Duncan favored emancipation, opposed secession, and refused to support the Confederacy.
