Originally from a French Hugeunot background in North Carolina, Amis moved to Tennessee circa 1781-1782. He had acquired acreage through a land grant, and by adding to his holdings, owned several large tracts by the time of his death in the late eighteenth century. Amis developed his business interests and built his house simultaneously. He owned and operated a store, blacksmith's shop, distillery, saw and grist mills, and tavern. The land on which Rogersville was established originally belonged to Amis. One of Amis' fourteen children married Joseph Rogers, the founder of Rogersville who worked in Amis' store when first arriving in the area. The land on which Rogersville was developed was supposedly a present from Amis to the newly-married couple.

Amis had served as a Captain and Commissary of the North Carolina troops during the Revolutionary War, and had been elected to the Provisional Congress of Carolina held in Halifax in 1776. In 1788-89, he represented Hawkins County in the North Carolina Assembly, at which time he presented the bill for the establishment of a town at "Hawkins Courthouse," as Rogersville was first called.

Traditional history has stated that Amis hired a Pennsylvania stonemason, Thomas Harlan, to build his house. Although there are family papers and records in the house, it was impossible to check them for this information.

The home of this early settler is important as one of the earliest examples of Tennessee architecture extant.
