

7. Description

Describe the present and original (if known) physical appearance

An impressive piece of academic architecture, Founder's Hall (1868) on the campus of the Maine Central Institute is one of the most beautiful structures in Pittsfield, Maine and a fine example of institutional use of the Italianate style.

The three story brick structure has a granite foundation and ornamental wood trim. This detailed trim can be seen in the denticulated cornice which underlies the hipped roof. The 9-bay-wide main facade faces east and has a protruding 3-bay section which extends beyond the plane of the facade. On either side of this projection are the main entrances to the building which have had simple porticos added to them to protect from ice falls from the roof. Located on the roof is an octagonal bell tower with a bell-cast roof. Each of the eight sides of the bell tower are open with wooden details mimicing tracery. The sides of the building are four-bays in width.

Fenestration is 2/2 throughout the building except for tall composite windows located in the facade projection and which are flanked by brick quoins. The 3rd story windows are capped by semi-circular brick arches and the remaining two floors have segmental arches.

Statement of Significance (in one paragraph)

Founders Hall, located on the campus of the Maine Central Institute in Pittsfield, is significant both in its architecture and importance as an educational institution.

The school was chartered as a private academy on February 1, 1866 and opened to students August 30, 1866. The cornerstone of Founder's Hall was laid in 1868 and by 1870 the lower floor had been completed. Donations finished the structure and in 1877 the final touch was added--a bell from the town. For the last 110 years this structure has remained the focal point of the campus.

Architecturally, this building is an excellent example of mid-19th century Maine academic architecture and it is rare that an educational structure of this type is found on such a grand scale. The building still dominates the campus despite the addition of numerous more modern buildings.

Maine Central Institute has long provided high quality secondary education for this large inland rural area at very modest cost.
