(CONT'D) HISTORICAL NARRATIVE (FROM ORIGINS TO PRESENT):

This building was constructed as a fire station in 1920. In the early 1950's, the First National Bank of Columbus secured the property and converted the structure from a fire station to a branch bank. During the bank's stay in the building, it leased half of the structure to the Columbus Chamber of Commerce for office space. In the latter part of 1955, First National closed the branch, and, as a result, the building remained vacant for several years. AAA Vacuum Cleaner Supply House, Inc., later occupied the property. Presently, the structure is vacant.

LEVEL OF SIGNIFICANCE: Local

STATEMENT OF SIGNIFICANCE (ARCHITECTURAL AND HISTORICAL): Architecture: This building is significant as it shows the adaptation of the Bungalow style to meet community needs, rather than just residential. Thus, this Bungalow type fire station employs a tile roof, wide eave overhangs and the proportioning of that style while meeting the needs of a fire station. Local This building is significant as a 1920's Columbus fire station, which served the downtown mills and Broadway business establishments.
