

DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

Cranberry Village was established in the colonial period and functioned as a stage stop along the Philadelphia - Amboy (New York Harbor) route. A real estate advertisement in 1775 describes a 400 acre property "situate in the town of Cranberry, in the county of Middlesex, adjoining the stageroad leading to Amboy ferry..." (<u>New</u> York Journal 1/5/1775.)

Another property advertisement for Cranberry in the <u>Pennsyl-vania Gazette</u> in 1775 discusses advantages of the house in specific, but is applicable to the town in general - "land at Cranberry... which is situated along the public road, about the center between this city (NY) and Philadelphia. It is a good stand for trade, a store having been kept there many years with advantage, which is likely to increase by the establishment of a weekly stage through Cranberry." (Pennsylvania Gazette, 1/4/1775.)

The Cranberry Mills, erected by Thomas Grubbs about 1737, established the nucleus of the village. Up for sale in 1777 the mill is described as being "on a good stream, within twelve miles of water carraige to New York, and fifteen to Philadelphia, is an excellent stand for county work, well situated, and in good order for merchants work, having two pair of stones, one pair which is very good for making flour... The lot...consists of about three acres and a half of the best meadow in the county, on which are erected, besides the mills, a comfortable dwelling home, convenient shop for a cooper, and a still and a malt house which are not quite finished." (Pennsylvania <u>Evening Post</u>, 8/23/1777.) The mill was destroyed by fire in 1860, rebuilt, and subsequently destroyed again. The site of the mill is on the west side of Main Street, south of Cranbury Brook, within the Firehouse property and Memorial Park.

The village developed around the mills and as late as 1810 contained only 18 houses.

The major development of Cranberry was during the second and third quarters of the 19th century in the Jacksonian period.

Gordon's <u>Gazetteer</u> indicates that in the 1830's Cranberry was "on the turnpike road leading from Bordentown to South Amboy, sixteen miles from the former, 185 miles from W.C. (Washington City, and 15 miles from Trenton; pleasantly situated in a level county, and light sandy soil; contains a Presbyterian church with cupola and bell, an academy, a grist mill, two tanneries, three taverns, two stores, and from 60 to 80 dwellings. Cranberry brook, tributary of the Millstone river, flows through the town." (Gordon, <u>Gazetteer of</u> the State of New Jersey. 1834, p. 124)

STATEMENT OF SIGNIFICANCE

Cranbury is the best preserved 19th century village in Middlesex County. Its collection of fine frame buildings ranging from the late 18th century to the early 20th century project an excellent protrayal of the 19th century.

While there are many small 19th century cross-road villages or small mill towns in New Jersey, few are in such an undisturbed environment as that of Cranbury.

Most of the buildings in Cranbury can be portrayed as vernacular Greek Revival or Victorian although many exhibit features which appear to have been influenced, if not directed, by the masters. Federal, Greek Revival, Italianate, and Queen Anne styles and details are all in evidence throughout the town - albeit sometimes in awkward dimensions.

Rather than just reflecting the quality of an architect/ builder, however, Cranbury embodies the hopes and aspirations of the nation in the mid-19th century. Optimism, faith, and reasoned growth are part of what Cranbury represented and continues to represent.

It is this assemblage of buildings - historically and architecturally - which makes Cranbury an attractive entity unique from any other contemporary villages. It is this identity which sets Cranbury aside from its nearby surroundings of look-alike suburbs and modern commercial developments creating a significant historical village.

Architecture

The architectural styles in Cranbury range from the Federal period to the 20th century bungalow. Primarily vernacular in design the buildings nonetheless project an aesthetic appearance and many fine details.

Description (continued)

About ten years later Cranbury is described thusly: "The village is principally built on a single street and contains two Presbyterian churches, two academies, 73 dwellings and about 600 inhabitants." (Barber and Howe. <u>Historical Collections of New</u> Jersey. 1844, p. 319.)

Today there are some 218 major buildings in the Cranbury Historic District. Less than 20% of these structures were built after the 1930's. Twenty-one houses were constructed around the beginning of the 19th century, 87 in the mid-19th century, 21 in the late 19th century, and 49 in the early 20th century. The major period of construction in Cranbury was from 1840 to the 1880's.

1 North Main Street - John S. Silvers Estate. 1886, 2 chimney, clapboard (aluminum siding). 3 story; gable end in front - triangular window; portico; ogee roof; columns; entrance - triangular pediment; dentils over windows & porch portico; windows with pendant & brackets; 3 bays; front porch with Victorian columns & brackets; Victorian square dormer. 2 1/2 story frame carriage house in rear of property. 15 North Main - 3rd quarter 19th century, altered. Aluminum siding and aluminum shutters; 2 story; 5 bays, 3 bay porch; Roman Doric columns; entrance - vertical panels, 2 panels top; roofline - bracketed cornice, single pane sash.

17 North Main - 3rd quarter 19th century, 2 1/2 story, clapboard; 3 bays; double door with rectangular trim; brackets; windows have label molding; upper front windows, hood mold; bracketed cornice; louvered shutters. Cross gable front.

19 North Main - c.1874. 2 1/2 story; chimneys, originally 2, now 1; clapboard; 5 bays; double door with rectangular transom; 3 bay porch with Victorian columns & gingerbread; exterior windows with cornice; louvered window shutters; 2/2 sash. Decorative slate roof.

21 North Main - United Methodist Church property; 1870's Clapboard; hood mold with pendant trim; tower - louver - hood mold with pendant; rose window with hood mold and pendant; double door - rectangular trim; side window - stained window. Church school addition 1959. $pi_{0.4}$

23 North Main - Old Cranbury School - 1896. Good example of small-town public school architecture of that period. 2 1/2 story brick edifice, gable roof, central projecting pavilion. National Register 6/21/1971. Picks #2014 208

25 North Main - 3rd quarter 19th century. 5 bays; aluminum siding; doorway broken pediment; dentils; Greek Doric trim on sides; polygonal bay window.

27 North Main - 2nd quarter 19th century. 2 story - aluminum siding; 5 bays; one bay entrance porch with brackets.

29 North Main - 1920's. Stepped gables; 4 bays; double door; rusticated block building.

39 North Main - c.1850. House consists of two houses put back to back; vinyl siding; 6 bays; 4 bay porch; entrance - doorway rectangular transom & sidelites; Roman Doric columns on glass enclosed porch. 2 1/2 stories. Slate roof.

41 North Main - John Nesbit House, 1804, mid-19th century. 2 1/2 story; clapboard; louvered shutters; 5 bays; double door, rectangular transom with leaded glass. Polygonal bay window. Windows all 2/2 sash. One story side office wing with modern store front. The center hall has an open staircase with a heavy turned newel and twined balusters. 57 North Main - (Cranbury Market; delicatessen) asbestos siding on upper level, board & batten on lower; 3 bays. Early 20th century, extensively altered.

61 North Main - Late 18th century. 2 1/2 story; clapboard and imbricated shingles; 2 bays; 1 bay porch with Victorian columns; cornice trim on windows; louvered shutters.

63 North Main 1930 - Aljon Office, Charlie's Barber Shop, Dandelion Shop, 2 houses in back, 2 apartments with shops. Stucco and cedar shakes; 5 bays.

65 North Main - Post Office. 1971. 1 story, brick, 5 bays, double door with rectangular transom.

67, 69, & 71 North Main - 67: (rear) 2 1/2 story; attached garage, 3 bays, synthetic siding. Modern - ca. 1940's.


75 North Main - 3rd quarter 19th century. 2 story; gable roof; 4 bays upper; 5 bays 1st floor; 3 bay entrance porch; 2 single doors; clapboard siding; Victorian columns on porch; gingerbread; louvered shutters. 2/2 sash.

77-79 North Main - Wayfarer's Inn. 3rd quarter 19th century. Pegged rafters. #77: 2 story; outside chimney north side; 5 bays; louvered shutters; center entrance; porch across front; Victorian sawn scroll brackets on porch posts; gable roof. #79: 1 story; center recessed entrance; large store-display windows; squared false front on gable roof. 1930's store.

81-83 North Main - #81: 1 1/2 story; porch across front; gable roof; Victorian gingerbread decorative posts on porch; side front entrance; 3 bays; clapboard; louvered shutters. #83: 2 story; gable roof; 6/6 sash; center entrance; 3 bays; louvered shutters; porch across front; spindle railing and porch frieze (spindles); curved, spindled frieze in center. Timber Dam Cribbing

During construction of the federally funded Cranbury Township sewer system workmen encountered a large wooden structure about four foot beneath the surface near Lake Brainerd. Work in the area was soon halted and representatives from Historic American Engineering Record and the New Jersey State Museum made a brief examination of the exposed wooden structure. Donald Jackson of HAER felt that the structure was part of a timber crib dam dating from the early to mid The lake lay within 25 feet of the partially exca-19th century. vated trench and it was apparent that the water was being impounded by this timber cribbing. The wood exposed was probably only a small portion of the entire timber cribbing, but bearing a striking resemblance to the crib dams illustrated in James Leffel's book Construction of Mill Dams (1881). The threat of damage to this dam, which was holding back the water of Lake Brainerd, necessitated abandonment of the excavation and backfilling the exposed timbers and reroute the sewer line to avoid the dam. Prior to this, fortunately, this engineering artifact was photographed and recorded.

The Federal style buildings in Cranbury are best identified by the elliptical doorway motif. The Brainerd Institute, 53 and 85 North Main and 47 South Main Streets all exhibit this feature in Cranbury and date from the mid-19th century - quite late for Federal details. Earlier buildings such as the Cranbury Inn, 68 North Main Street, 16 and 49 South Main Street do not have this feature although their form and interior detailing does suggest the Federal period. The house at 43 South Main Street has an early Federal form, but also features an added pattern-book Greek Revival entrance portico.

The Greek Revival building is the most predominant form in Cranbury. Fine examples such as the First Presbyterian Church, 10 Park Place, 26 Maplewood Avenue, and 11 North Main Street rival the best Greek Revival buildings in New Jersey. Numerous other mid-19th century dwellings in Cranbury represent the vernacular of the Greek Revival style at its best. The building as constructed in Cranbury was a five bay, center hall building or a small three bay, side hall unit. The side and fanlight doorways are typical as are the simple paneled frieze and corner boards. Examples are at 6 Westminister Place and 5 South Main Street. Other Greek Revival buildings in Cranbury are at 1-5 Scott Avenue; 11,31,42, and 54 North Main and 12,16,41, and 57 South Main.

Carpenter Gothic features are not uncommon in Cranbury, but generally are incorporated in buildings with other features. Two of the clearest Victorian Gothic buildings are at 5 Prospect and 10 South Main Streets.

The Italianate form is represented by 1 Prospect Street, 39 South Main Street, 95 North Main Street, and the S. Jernee House at 9 Park Place.

Conservative building forms held true in Cranbury for nearly half a century and as a result fanciful later Victorian buildings are uncommon in the village. Two exceptions are the Queen Anne style buildings erected for the Silvers in the 1880's. The one is at 1 North Main and the other at 46 North Main. A simpler example of the style is the house at 101 North Main Street. Colonial Revival buildings are represented by 40 South Main Street and the Old Cranbury Schoolhouse.

Several 20th century bungalows are also in the district. Two particularly fine examples are side by side at 86 and 88 North Main Street and were built in the 1920's.

In total, Cranbury has a fine collection of architecturally significant buildings. Not all of them have been pinpointed in this essay which singles out the finest and the most representative. The major visual impact of the Cranbury District, however, is its overall ambiance. Although differences in styles and details are common from building to building the overall scale and massing of the structures are uniform providing aesthetic streetscapes throughout the village.

Commerce

Main Street in Cranbury has functioned as the commercial center of the village from the 19th century. Many of the mid and late 19th century buildings are still extant, although the integrity of some have been jeopardized over recent years with unsympathetic alterations to the first floor store front facades. Examples of these commercial buildings include 60 North Main Street, 11 North Main Street, 13 North Main Street, 31 North Main Street, 33 North Main, 55 North Main, Wayfarer's Inn at 77 and 79 North Main Street, and 14 South Main Street, in addition to the 18th - 19th century Cranbury Inn, a functioning inn and tavern for nearly two hundred years.

Originally owned by Colonel Richard Hardley of the New Jersey Militia in 1800, Peter Perrine built a house next to the tavern. This house was converted into the U.S. Hotel in 1808 by Captain Timothy Horner. Around 1920 the name became the Cranbury Inn.

The First National Bank was organized in April 1884 and occupied its present building since 1898. The Cranbury Savings and Loan Association was founded in 1921.

The first newspaper in Cranbury was the Cranbury News by R. M. Stults on January 5, 1882. The Cranbury Press established in 1885 was founded by George W. Burroughs and is located at 13 North Main Street.

The firehouse is built on the property where the old grist mill and a saw mill stood. In 1948 the site next to the brook became the Memorial Park. Cranbury has another new park off Maplewood Avenue.

Over the years Cranbury has had its share of blacksmiths, wheelwrights, and carriage manufacturers; grocery shops, bakeries, shoe and boot shop of Daniel Hoagland, and the Spice Mill established in 1865 by John S. Davison and later known as the J. S. Silvers Bros. and Co. which was destroyed by fire.

Military

GEORGE WASHINGTON IN CRANBURY

Before the Battle of Monmouth, General LaFayette wrote to General Washington on June 25, 1778: "The detachment is in a wood covered by Cranberry Creek, and I believe extremely safe." A letter from Colonel Alexander Hamilton which LaFayette enclosed in the foregoing, was dated "Doctor Stile's House, Cranberry Town 9 o'clock".

Early the following morning LaFayette wrote again to General Washington before proceeding. During the day General Washington came to Cranbury where he wrote to LaFayette and General Lee. The intense heat of the weather from whch the troops were suffering and a storm that came on prevented General Washington from advancing beyond Cranbury on June 26, 1778.

Religion

With the Dutch, the Friends, and French Huguenots in this section, the Presbyterians made an agreement to join the church of England persuasion, and a building was erected and used for services by the various groups. In 1738, the Presbyterians sold their interest in the building.

In July 1739 James Rochead conveyed to Coert Van Voorhees and Thomas Story a lot adjoining the mill property "to be the use of the Elders and Deacons of the Presbyterian Church of Cranbury for erecting a house of worship."

A church was erected in 1740. A new building was built in 1788 on the site of the present church which was built in 1839 and enlarged in 1859. The first chapel was built in 1878 and brought to its present state in 1960.

The Second Presbyterian Church of Cranbury was founded in 1838. The two churches were joined in 1935. The Second Church building was razed and a monument erected on the site. Its Westminster Cemetery continues to be the burying ground for many families.

The lake, and cemetery adjoining the First Church have been named for David Brainerd who preached to the Indians in or near Cranbury during the summer of 1745.

The cornerstone of the present Methodist Church was laid in 1848. Prior to that occasional services were held from 1817 to 1848 in private homes.

Archeological Surface Survey Conducted on August 17 and August 28, 1975 for Cranbury Township Sewerage System

The research methods employed to determine the presence of archeological materials on the easement of the Cranbury Township sewerage project were consultation of documents in the possession of the Bureau of Archeology and Ethnology of the New Jersey State Museum, library research (primarily in the New Jersey Room of the Alexander Library, Rutgers University), and on site surface survey of the projected sewerage easement. No clearance of surface vegetation was necessary, and no sub-surface excavations of any kind were performed in the project area. Surface indications were sufficient to establish the existence of archeological materials along the proposed easement area.

Various archeological documentary sources (Cross 1941, Skinner and Schrabisch 1913, Spier 1915) were examined at the Bureau of Archeology and Ethnology of the New Jersey State Museum in Trenton, New Jersey. These materials yielded negative information concerning the possible occurrence of archeological artifact features, or sites in the proposed project area. Interviews with a number of local residents resulted in negative information in regards to the occurrence of archeological manifestations in the impact project area.

A review of the available historical documentary records showed that settlement in the Cranbury area began in 1680. The focus of this early settlement occurred near the confluence of the Millstone River and Cranbury Brook, approximately four miles west of the present village center (Curry 1919:13). Settlement in Cranbury Village commenced during the late 1730's when a grist mill, probably owned by Thomas Grubbs, was built on the southern bank of Cranbury Brook, just west of Main Street (Wall & Pickersgill 1921, 2:448). This same mill burned down in 1860, but it was promptly rebuilt (Wall & Pickersgill 1921, 2:449). The site of this mill has been corroborated by its notation in numerous nineteenth century maps of the county and the township (Anon. 1876, Walling 1861, Walsh 1975). The mill itself has since disappeared and no surface traces of it remain.

Cranbury has historically supported blacksmiths, wheelwrights, carriage and wagon builders, tanners, and other local trades (Wall & Pickersgill 1921, 2:449). These occupations have since left the town, and Cranbury is today a center of light industry and a suburban community.

Two walks over the surface of the proposed sewer easement were performed during August, 1975. The first discovered a late nineteenth century surface bottle dump and a large scattered surface dump. The bottle dump, located on the north bank of Cranbury Brook along the proposed 8" force main easement, contained numerous sherds of mason jars and spice bottles. The spice bottles bore the

inscription "L.S. Silvers and Bro., Co., Cranbury, N.J." These bottles were produced by "the principal business of the town, the American Steam Coffee and Spice Mills, established in 1866" (Wall & Pickersgill 1921, 2:450). The dump was probably associated with a large late nineteenth century structure (known as the Manse) located on the west side of Main Street just north of Cranbury Brook. It was recommended that the proposed sewerage easement be rerouted to avoid the bottle dump.

Scattered surface dump activity was also noted occurring along the proposed easement by the ridge that borders the flood plain of Cranbury Brook west of the First Presbyterian Church cemetery. Surface occurrences in shallow soil of glass fragments, ceramics, metal, and plastic indicated that dumping had been occurring in the area for at least seventy years. This impression was confirmed through surface re-examination.

All historical dump sites have a certain amount of archeological significance. This significance is directly dependent upon other, more general archeological research strategies. Simply put, a dump is rarely worth excavating alone. The Cranbury area has been inhabited by European populations for at least two hundred and fifty years, a respectable time depth in this region. This fact strongly suggests that the township should be the subject of a regional archeological survey at the earliest opportunity. The two dumps sites would then be valuable in reconstructing and explaining past lifeways in the township.

Cranbury Historic District Cranbury Middlesex County New Jersey

Boundary Justification

The boundaries of the Cranbury Historic District are easily justified. East of the district are two modern housing developments sandwiching a recently created township athletic park. Further east is the major north-south highway, U.S. Route 130.

Outside of the western boundary is modern housing in the southern sections; a large nursery and school in the central portion; and undeveloped farmland in the northern area. The north delineation is a natural boundary (small stream) and a farm property line providing an appropriate and convenient geographic boundary.

Beyond the southern boundary the area becomes primarily agrarian and remains so approaching U.S. Highway Route 130.
