	IV. SIGNIFICANCE	STATEMENT OF SIGNIFICANCE (ARCHITECTURAL AND HISTORICAL): The Ben Hill County jail is architecturally significant as Fitzgerald's prime Romanesque style structure. Although its architecture was compromised by the removal of its battlemented tower and original portico, it still retains architectural features such as Tudor arches and battered walls that are unique in the area. It is also significant for its fire proof construction. The jail is significant in terms of <u>politics and government</u> as one of the first two structures created by the newly formed Ben Hill County government. shows slight demarcation where tower was removed. Old photograph shows original front porch (replaced in 1937) as a flat roofed portico with square modillions topped with a surrounding balustrade. The front (south) and west (recessed portico) entrances feature Tudor arches. An arcaded corbel table encircles all but the front left corner of the cornice; a string course encircles the entire structure at the second story window sill level. The south entrance leads to the two story original sheriff's living quarters (paneled and remodeled over the years), while the west entrance leads to the cell portion of the jail and spiral metal stairway leading to the second story gallows and cells. The prison portion of the jail has concrete floors, riveted strap steel cells, plaster over brick walls, and a flat corrugated metal ceiling with concrete encased metal beams. The building is now undergoing interior renovation in order to meet code requirements.

The Ben Hill County Jail, facing one of Fitzgerald's original brick streets, is located on the same city block as the courthouse (now separated back-to-back by an alleyway). The lot also contains a non-historic small brick garage building built in 1951 as a replacement for a wooden garage shed.

\$12,426 was let to the Manly and Lamon Construction Co. of Dalton, Georgia (competing bidders were the Pauly Jail Co., Stewart Jail Co., F.M. Dodson Co. and Little and Phillips.) On September 2, 1909, roughly seven months later, the county commissioners approved the completed work.

Sheriffs and their families lived in the front living quarters of the jail from 1909 until the 1950's, according to Mrs. Ruth Pryor, widow of Sheriff Griner, who was killed in office. The Griner family lived in the jail from 1937 to 1952.

The Ben Hill County jail has served continuously as the county prison until recently, when prisoners were temporarily moved so the jail could be renovated to meet state code requirements.
