window and door openings are irregular. There is only one didge dormer, two gable dormers, and two chimneys with distinctive round openings. The living room does not have a basement under it nor attic above. It is two steps down from the rest of the house and has a roof rafter and tie beam. Casement windows open inward over tile sills. There is a basement under and partial attic over the rest of the house. There is a grate in the ceiling under the ridge dormer to provide ventilation for the room beneatb.

This house is architecturally significant because it is one of a group of houses built in Milwaukee County by Arnold F. Meyer according to Ernest Flagg's methods of construction. It is also significant because it isone of four houses built by Meyer for members of his own family. This house was built for his brother Starke Meyer, manager of the Milwaukee Tug Boat line
