Describe the present and original (if known) physical appearance

Situated approximately three miles southwest of Macon, Tennessee, the Mebane-Nuckolls House (ca.1855) is a two story Italianate building of brick with a one story rear ell. Facing west, the house is located on a wooded, relatively flat site of 15 acres on the gravel Collierville-Macon Road about one mile south of Macon Road. Also on the nominated property are the original frame kitchen, a nineteenth century frame smokehouse, a nineteenth century log barn, the Mebane cemetery, and the Starkey Hare cemetery (an early settler of Fayette County and the original owner of the surrounding land.) Bordered by open farmland, the site retains its architectural and historical integrity to a high degree.

The front (west) facade is five bays wide with a central doorway having plain sidelights and transom with simple pilasters and a low pediment. On the first and second stories, the narrow 6/6 front windows have louvered shutters and elaborate cast-iron hoodmolds which project from the facade. The brick walls are laid in American bond and have traces of penciling. The low, hipped roof is covered with standing seam metal sheets and has a denticulated cornice with ornate console brackets of terra cotta. The flat roof of the three bay, one story front porch is supported by the paired wooden columns on wooden pedestals separated by low, four-centered pointed arches and paired brackets.

The identical north and south elevations of the house have interior end chimneys and a window on both stories near the facades' rear (east) corners. These windows are the same as those on the front facade with hoodmolds and shutters. The fenestration of the rear (east) elevation consists of a window on each story similar to the building's other windows but with a jack arch.

Attached to the center of the rear elevation is a long, one story brick ell with a gabled, standing seam metal roof. The 6/6 windows have straight lintels and louvered shutters. A shed-roofed veranda with simple pillars runs the full length of the north and south elevations of this wing. A door surrounded by sidelights and a transom is found on the south elevation of the ell.

The interior of the two story section of the house was designed to follow the standard plan of a central hall with two rooms on each floor. The open well, three-run stair is located at the rear of the first floor hall and has a turned newel post and balusters in addition to jigsaw brackets on the risers. There is heavy architrave molding around the windows and the doorways, which have paneled jambs. Other original or early features include trabeated mantels and doors with narrow 2x2 panels and simple hardware.

The rear ell contains two large rooms with fireplaces at their east ends. The west room has moldings with shouldered architraves and paneled doors, while the woodwork of the east room is much plainer.

Immediately to the south of the ell and connected by a short walkway is the one-by-two-bay frame kitchen. The one-story building has a tar-papered hipped roof with a central chim-ney and multi-pane windows with louvered shutters.

There are two mid to late-nineteenth century outbuildings on the nominated property, a frame smokehouse and log barn. A short distance to the east of these structures is the Mebane cemetery. The plot is surrounded by a simple cast-iron fence and has several nineteenth-century headstones and obelisks. Adjoining this cemetery is the simply-marked burial site of the early Fayette County settler, Starkey Hare, and his family.

Statement of Significance (in one paragraph)

The Mebane-Nuckolls House (ca. 1855) is nominated under National Register criteria A,B, and C for its local architectural significance and its historical associations with the development of Fayette County. The building is a rare and outstanding local example of the Italianate style. The property is further important for its connections with prominent local families, particularly the Mebanes.

The house was built around 1855 for John Howe Mebane (1789-1875), son of Brig. Gen. and U.S. Congressman Alexander Mebane (1744-1795) of North Carolina. The site of the nominated house was bought in 1855 from a local land speculator, B.H. Porter. According to tradition, the only building on the property at that time was a simple log house located somewhat north and east of the cemeteries. Prior to establishing his own home, Mebane had been the manager of the Fayette County plantation of his brother, Dr. William Mebane. By the time of the Civil War, John Howe Mebane had become one of the largest land owners in Fayette County. Upon his death in 1875, his son, William Graves Mebane (1838-1882) inherited the house. Having graduated from the University of North Carolina at Chapel Hill and served as a Confederate Captain, the younger Mebane became a successful farmer like his father.

The ownership of the house was to remain in the Mebane family only a few more years, for at William Graves Mebane's death in 1882, the property was bought by Nathan Blaine as a wedding present for his daughter, Maggie V. Nuckolls. The house and land were passed to her descendents until the building and a portion of the acreage were purchased in 1984 by Mr. and Mrs. W. W. Perkins.

The Mebane-Nuckolls House is relatively unaltered from its original appearance on both the exterior and interior, retaining almost all of its original moldings, doors, hardware, and decorative features. The high degree of its preservation and architectural sophistication is exceptional in rural Fayette County (est. 1824), one of the poorest areas of the state. Among the approximately twenty pre-Civil War houses left in Fayette County, the Mebane-Nuckolls House is a rare and important local example of the Italianate style. The flat-roofed porch with paired columns on pedestals, the sculpted hoodmolds, elaborate brackets, and symmetrical fenestration exemplify this style.

The building is also noteworthy as one of the county's very few residences constructed of brick before the Civil War. Frame construction and the Greek Revival style were much more common in the area, as seen in Hancock Hall (LaGrange, 1857) and Alba Villa (Somerville, 1846). Although Fayette County has two small historic districts in LaGrange and Somerville, the more rural parts of the county have extremely few houses of architectural or historical interest.
