Describe the present and original (if known) physical appearance

The Jackson Commercial Historic District comprises over three-quarters of the central business district in Jackson, a town of approximately 3,800 people in Jackson County. The district contains 34 buildings and one historic clock located on Second Street (Jackson's main commercial thoroughfare) between Sheridan and White streets, and four buildings on side streets within one block of Second Street. The northern boundary of the historic district corresponds with the central business district's northern limits, while the southern boundary of the historic district is drawn to exclude some ineligible commercial buildings at the south end of the main street. Outside of the historic district's boundaries are commercial buildings which do not fit visually within the district or add to its significance because of substantial alteration or more recent construction dates.

The Jackson district contains 34 buildings and one historic clock which were built between 1880 and 1944. 32 of the buildings were built before 1928. Most of the buildings are faced with brown pressed or textured brick and most have buff colored limestone trim. Several are mildly Classical Revival in style and two have Sullivanesque foliated stone detailing. 25 of the buildings are two stories in height while nine are one story tall. 32 of the buildings are in good condition while 2 are in fair condition. Although most of the buildings have been altered at the storefront level, most are intact above the first floor and many of the alterations are reversible. As a whole, the district contains structures which form a visually cohesive group of nineteenth and early twentieth century commercial structures which retain their overall architectural character.

The historic district contains 30 contributing buildings, 1 contributing object (the Jackson National Bank Clock), and 4 non-contributing buildings (buildings which are less than 50 years old, or whose integrity has been seriously compromised by alterations).

The Hutchinson Building is a two story brown brick structure at the southwest corner of 2nd and Ashley Streets. The building retains a brick cornice, four large rectangular windows with limestone sills and lintels on the main facade, ten rectangular windows with limestone sills and lintels on the north facade, and a rear (north) storefront opening. Exterior alterations have been limited to remodeling the storefronts. Built in 1898, the Hutchinson Building was originally owned by M.B. Hutchinson and houses Hoaas Clothing. In later years it housed Mundell Clothing, By-Rite Grocery, and other businesses.

Statement of Significance (in one paragraph)

The Jackson Commercial Historic District, comprised of 34 buildings and one historic clock concentrated on and near Second Street, is historically and architecturally significant as a collection of largely intact small late nineteenth and early twentieth century commercial buildings which form a visually cohesive display of commercial architecture built over a 50 year span. The buildings are significant because they represent Jackson's importance as a regional trade center serving a large rural population and because they present an excellent survey of the type of small businesses which formed the early underpinning of a small railroad town's commercial economy.

Located on the Des Moines River near Minnesota's southern border, the town of Jackson was named the county seat of Jackson County in 1867. Jackson quickly became a center for government, commerce, trade, and the collection and marketing of agricultural products as the surrounding farmlands were settled in the late nineteenth century. After rail service reached the community in 1871, small businesses flourished and commercial buildings were constructed in a four block area along Second Street. Businesses were first housed in woodframe commercial buildings which were often subject to fire and were eventually replaced by more substantial and theoretically fireproof brick structures. Jackson's commercial historic district contains an interesting collection of brick commercial buildings which range from 1880 structures through buildings which were constructed in the late 1920s which represent a peak in the community's commercial prosperity. The district as a whole represents the fruition of the efforts of the pioneer businessmen who first settled Jackson and laid the groundwork for its commercial development.

The buildings in downtown Jackson represent a range of stylistic variations popular in commercial architecture during the late nineteenth and early twentieth century. Interestingly, none of the buildings are extremely ornate, but rather they are surprisingly compatible in size, design, and materials. The earliest buildings feature intricate Victorian detailing (i.e., foliated carving, heavy cornices, oriel windows), the buildings constructed during the period 1905-1919 display a restrained and handsome Classical Revival influence, and the later structures are more simple in design as stylistic preferences changed after World War I.

The buildings included in the historic district represent many of the forces important to the commercial development of the region. A variety of retail businesses including groceries, clothing and dry goods stores, hardware, and implement dealers are represented in the district. Saloons, cafes, harness shops, fraternal halls, movie theaters, and the offices of early physicians are included. The district contains three bank structures, the Jackson National Bank, the Brown National Bank, and the First National Bank, which contributed to and profited from the development of commerce in the region. The buildings in the district also represent the accomplishments of individuals.

A two story, brown brick building standing at the northwest corner of 2nd and Ashley streets, the Berge Brother's Block originally had a typical Victorian storefront with a canted corner entrance, a heavy metal cornice, segmental arched second story window openings, and a rear (south) storefront. Although the building retains segmental arched windows with stone keystones and sills and a rear storefront opening on the south side, the main facade was altered circa 1940. This facade now features decorative brickwork at the cornice level, rectangular 1/1 sash, and a glass and metal storefront. Alterations to the building have included remodelling the main facade and partially filling the windows and storefront on the south side. The building was constructed in 1894 for use as the Berge Brothers Mercantile Company, Jackson's largest grocery store at the time. The store sold groceries, clothing, and general merchandise, with the second floor used as an opera house. In later years the building housed the National Tea Grocery and the Ben Franklin Store.

> Gervais Jewelry is a small, one story commercial building with a facade faced with brown brick with buff colored limestone trim. The building has a projecting parapet wall with stone coping which rises above a circa 1945 storefront with a permanent metal awning. The remodelling of the storefront is the building's major exterior alteration. The building was constructed in 1917 and first housed the Jack Sprat Grocery operated by Ray Hansen. After housing Norville Carlson's Fairway Grocery, the building eventually became Gervais Jewelry owned by Lionel A. Gervais.

> The building which now houses the northern portion of Strom's Clothing Store has been remodeled with ca.1960 alterations which obscure the original main facade. These alterations obscure a two story brick veneered building which between 1894-1900 appears to have combined two frame buildings to form the present structure. The building has housed a variety of businesses including an undertaking and furniture store operated by V.W. Avery. The main facade is presently faced with smooth plaster, rectangular 1/1 sash, and a modern storefront.

The Ashley Drug Store building is a two story structure which is one of two buildings within the historic district which feature second story oriel windows on the main facade. The main facade is faced with brown brick with light mortar joints and buff colored limestone trim. The second story oriel window is flanked by pilaster strips with Ionic capital and the building has a stone cornice, sill, and coping. The storefront was altered ca.1960 and the second story windows have been replaced with new brown framed 1/1 sash. The building constructed in 1913 and housed Ashley Drug Store, operated by 0.A. Ashley. Later occupants have included Westby Drug, Joul Drug, and, most recently, The Clothes Tree.

The Saloon is a two story, dark brown brick building which features second story rectangular 1/1 windows and small transoms across the main and north facades, and decorative brickwork in a checkerboard pattern at the cornice level on the main facade. While the main portion of the building was constructed in 1894, the 2nd Street facade appears to be a result of a remodeling which dates to ca.1910-1920. The building was purchased by the Heilman Brewing Company in 1899 and operated as a company saloon for 18 years. It later housed a succession of other businesses including Hronicka Hardware, Mundell Clothing, and Sears.

> The clock which now stands at the northwest corner of 2nd and Sherman streets was originally installed in front of the Jackson National Bank, built in 1919-1920 just north of this site (now the present Jackson State Bank). The clock, fabricated of darkened cast metal, has clock faces on four sides and colored glass lettering reading "Jackson". The clock was given to the City of Jackson in 1950 and installed in its present location in 1984 after being refurbished by several community residents. It now serves as a visual focal point for Jackson's main street and a symbol of the business community's downtown improvement and promotion activities.

The Jackson National Bank, built in 1919-1920, is a good example of the monumental, Classically-inspired design which was popular for banks and other public and institutional structures nationwide in the early twentieth century. The main facade of the building, which is faced with smooth gray limestone, has colossal, fluted engaged columns and pilasters with simple capitals supporting an simple entablature with dentils. Above the entablature is a blind balustrade with urn shaped balusters. The facade is embellished with shields, garlands, and other relief detailing above and below the first story windows. The main facade is basically intact, although new windows and doors have been installed and lettering reading "Jackson State Bank" has been applied to the frieze. In circa 1983 the side and rear walls of the structure were faced with plaster covered panels and a drive-through teller port was added to the south side. The interior was also remodelled circa 1983. The Jackson National Bank occupied this building from 1920 until the bank closed in 1933. The bank was vacant until 1938 when the Jackson State Bank opened in the building under the leadership of Frank A. Mutuska, President, and Roy Trunk, Cashier. The Jackson State Bank has continued to occupy the building under several different owners.

The Burnham Grocery building is a two story brick structure faced with reddish-brown brick which has been painted green on the main facade. The second story of the main facade has two oriel windows with foliated stone bases, pilasters with stone bases

> The Leach Decorating Center building at the southwest corner of 2nd and Grant streets is a two story, brown brick structure with a rounded second story corner, rectangular 1/1 sash with transoms at the second story, and an intact metal cornice with modillions and dentils. The building is basically intact at the second story level. The main storefront and a rear storefront on the north facade have been recently altered, and three small square first story windows on the north facade have been filled with brick. The building was constructed circa 1900 and housed a clothing store operated by H.M. Burnham as one of its first occupants. The building later housed Davies' Store and is now Leach Decorating Center.

The Catholic Foresters' Hall is a large two story building at the northwest corner of 2nd and Grant streets. The building is mildly Classical Revival in style and faced with dark brown brick with sparse, buff colored limestone trim. The six bay south facade has an altered rear storefront and second story rectangular double hung sash. The main facade has a central entrance flanked by storefront windows, and rectangular double hung sash at the second story. At the top of the main facade is a date stone within a simple triangular parapet. The exterior of the building has been altered with new windows and shutters and remodelled storefronts. The building was built as the Catholic Foresters' fraternal headquarters, with a large meeting hall in the second story and four storefronts in the first story which have housed a succession of small businesses. The building is now the home of Muir, Meyer, Simons, and Costello law offices.

The Matuska and Skalicky building is faced with painted brick and has cornices with dentils on the west and north sides, brick pilasters with stone capitals and brick corbelling enframing the second story windows of the outer bays, stone keystones above the windows in the central bay, stone coping and a name plate above the cornice, and large brick pilasters supporting the storefront level. He served as president of the Jackson National Bank (included in the district), was the original owner of six of the other buildings in the district, and is recognized locally as one of Jackson's most important early businessmen.

The buildings which comprise the Jackson Commercial Historic District were included in a historic sites survey of Jackson County conducted recently by the State Historic Preservation Office. The survey staff determined that the commercial buildings in Jackson are an unusually intact, consistent collection of structures which as a group retain their late nineteenth and early twentieth century architectural character. Jackson's commercial district was found to be much more intact than the commercial districts found in surrounding towns in Jackson and nearby counties. In addition, the buildings create an important visual link to Jackson's commercial development as a southern Minnesota railroad community and regional trade center. By representing the development of commerce and commercial architecture in Jackson, the buildings contribute to an understanding of the Agricultural Development and Railroad Construction Context of the State Historic Preservation Office's preservation planning framework.
