

45. Description and House Plan:

A 2-story frame structure sheathed in weatherboard on the sides and rear and standing on stone piers. The gable-end facade is running bond brick terminating in an elaborate pressed metal cornice with a raised central tablet containing "Bank of Simpsonville". This parapet conceals the gabled standing seam metal roof. The two bays of the facade are set in a large recessed panel highlighted by dentilled brickwork at the top. The entrance is in the north bay: the south bay in the first floor consists of a Palladian motif window. Piercing is irregular on the south facade. A 2-story shed-roofed addition is located on the north side and contains stairs to the second floor. The nominated area contains one contributing building.
