45. Description and House Plan:

The Viney Fork Baptist Church is a one-and-one-half story rectangular building of cut sandstone. It was originally three bays on the axial facades. One bay of the west facade has been covered by a concrete block addition. The two original entries are found in the gable end. They are surmounted by a blunt pointed arch containing a fanlight with tracery matching that exhibited in the lancet windows. The stone portion of the front and rear ends at the roofline of the axial facades and the remaining wall is clapboard, now sided. Door and window sills are of stone. The gable end is capped by a short squared wooden bell tower.

Statement of Significance

The Viney Fork Baptist Church is significant under criterion C for the period 1802. as an example of a rural country church notable for its use of windows whose blunted arched shape represent a local interpretation of the Gothic style.

Verbal Boundary Justification

The boundary was chosen to follow the property lines of the lot historically associated with the church.

The boundary contains one contributing building.

14. History

Christopher Harris and Andrew Tribble constituted Viney Fork in 1797 as "The United Baptist Church of Christ on Muddy Creek." With a membership of twenty, it associated with the Tates Creek Association the same year. By 1799, its representation totalled forty-five members of "Viney Fork Church." During the great revivals, the church, like others, prospered and, in October of 1801, had 255 members and was, after Tates Creek Baptist Church, the largest congregation in the Tates Creek Association.

The Viney Fork Church dismissed many members until 1830 in order primarily for them to join new churches. The Campbellite schism in the Tates Creek Association left it only 46 members in 1830. Before the outbreak of the Civil War, its membership was 165; in 1869, membership had dropped to 50. The present membership is 167.

The stone building, made with local sandstone, was completed in 1802. Tim O'Neal remodelled the building with little apparent exterior alteration in 1886.
