Description of present and historic physical appearance:

The Holt Brothers Banking Company Building is a two-story, three-bay, brick commercial building with a rusticated first story, marble ornamentation, and flat roof. The structure is situated on the square in downtown Sandersville and encompasses its entire corner lot.

On the first story, the structure has an arched doorway in the center of the front facade surrounded by rusticated stone. Above the doorway, there is an entablature and a marble plaque which reads "1898." In the marble rustication surrounding the front door, there is a pressed plaque close to the ground which reads, "Chas. E. Choate, Architect and Builder," and there are some emblems next to the front door surrounds. There is a colored glass fanlight above the central doorway. The two storefronts, including glass panels, kick plates, and clerestories, have remained intact. There are now two metal awnings above each storefront.

On the second story, above the east and west shops there are three windows with a central window above the doorway and plaque. Above the central window on the second story is a rounded arch of brick. Along the roof line is an entablature with an architrave of brick and marble brackets supporting the cornice. The parapet is brick with marble detailing.

A similar three-part division occurs on the east side of the building, visible because of the corner lot on which the building stands. There is a parapet similar to that on the front facade with 1/1 windows, each window having the same segmented arch above set in a protruding brick "frame." Above each segmented arch, there is a string course

and small entablature. There is a door on the side of the building surrounded by rusticated stone as on the front facade. A marble string course runs along the bottom of the building on the east side.

The rear of the building is fairly intact with a decorative metal basement vent displaying "Atlanta Stove Works, Atlanta, Georgia." Metal bars cover the windows in the rear which point to the building's original use as a bank. The window openings are boarded but have brick segmental arches above and are flush to the surface unlike those on the side of the building. A curve runs from the side (east) roof line down the end of the structure--a Choate signature on his commercial buildings.

On the interior, there is a pressed metal ceiling and cornice line with square coffers. Two glass clerestory panels in the store front contain tracery and a third one is missing. There is a vault along the interior east wall of the building that has the same details surrounding it as in the W & T Railroad Building with two carved Ionic pilasters. The vault itself has the following printed on the door: "The First National Bank. The American Bank Protection Co., Minneapolis, Minnesota." It also features its original decorative paint scheme. There is wood wainscoting inside one of the shops which is chair rail height. On the second floor the building contains former offices with plastered walls, beaded wainscoting, wood floors, and several simple mantels. A hallway runs down the center of the space with offices on either side.

Significance of property, justification of criteria, criteria considerations, and areas and periods of significance noted above:

Narrative statement of significance (areas of significance)

The Holt Bank Building is significant in architecture because it is one of the most elaborate Choate-designed examples of commercial architecture in Washington County, and indeed one of the most elaborate commercial buildings in Sandersville and Tennille. It is one of two such property types within this multiple property nomination. It is also one of the earliest examples of Choate's work in the area.

Overall, the building is a good example of the late 19th-century "storefront" commercial building, found in virtually all Georgia communities as well as in Sandersville and Tennille. Its subdivision vertically into bays corresponding to storefronts and entrances and horizontally into storefronts and entrances on the ground floor and offices above is typical for this type of building. Its corner location makes it a landmark commercial building in downtown Sandersville with two significant facades. Architectural elements significant on the exterior include an unusual rusticated store front, round-arched front door, and marble voussoirs surrounding the opening. The detailed brick corbeling along the roof line is a strong element on the exterior and is significant in its detail and proportion. The characteristic Choate-designed "harp" motif or curved roofline is carried out on the rear. Significant interior details are traditionally late 19th century commercial in appearance. These details include a pressed-metal coffered ceiling, cornices, and display areas and transoms. The more classical inspired details typical of Choate are located in the upstairs space historically used as office space. These include turned balustrades and newel posts, beaded woodworking, and simple mantels with Doric columns.

This property meets National Register Criterion C for its architectural significance as a significant work of commercial architecture designed by Charles Choate very early in his local career.

The contributing resource is the building.

Developmental history/historic context (if applicable)

In November 1897, the Holt Brothers, a firm composed of Lewis and Lake B. Holt, purchased a lot located on old Watkins corner in Sandersville. The purchase was made at an auction in front of the Washington County Courthouse. In June 1898, the <u>Sandersville Progress</u> stated that the Holt Brothers Building of Sandersville was constructed at the corner of North Harris Street and fronted Malone Street with the rear of the building along Jernigan Street. It was a two-story brick building with ashlar marble according to the newspaper. The newspaper described the central door entrance featuring a stained glass fanlight and to the right the name "Chas. E. Choate - Architect and Builder" carved in marble.

The Holt brothers were bankers, farmers and businessmen, and they opened the First National Bank in their new building in 1901. Lake B. Holt was the president while S. M. Hitchcock was the cashier.

In June 1914, the Holt brothers sold their building to the First National Bank. By April 1930, Gordon S. Chapman, publisher of the <u>Sandersville Progress</u> and mayor of Sandersville, became the owner of the building and property.

Upon Chapman's death, his daughters Mary Jean Paris and Louise Chapman Orr acquired the building and in December 1976, Louise Chapman was the sole owner of the property. At this time, the building was converted to stores and office rental. Today, Our Shoppe and the Little Shoppe, both clothing stores, occupy the building on the first floor while the second floor remains vacant.
