

#### **Narrative Description**

The Riggs Spring Fire Trail is approximately eight miles in length and varies in width between four and five feet. For most of its length it is a graded trail with an unpaved natural surface. Exceptions include eroded trail segments in the drainage bottom where the trail has been reestablished through use rather than through deliberate construction. From Rainbow Point, the trail descends to Yovimpa Pass, and from there into the bottom of the Lower Podunk Creek drainage to Riggs Spring where there a new fence protects the spring from wildlife. From Riggs Spring the trail turns northward where it parallels Mutton Hollow. The trail alternately ascends and descends two north/south oriented ridge systems before the final gradual ascent along the base of north side of the "Promontory" and its return to Rainbow Point. On the plateau, the trail passes through ponderosa pine forest. Below in the drainage bottoms, one finds stands of aspen in well watered areas and oak in drier sites.

In general, the integrity of the trail is good. Although it has suffered from natural erosion and a general lack of maintenance, comparison of historical maps with the modern alignment indicates that the location of the has not changed significantly.

Narrative Statement of Significance

The Riggs Spring Fire Trail has local significance under National Register Criterion A for its association with the development of National Park Service (NPS) infrastructure in Bryce Canyon National Park (BRCA), and the involvement of the Civilian Conservation Corps (CCC) in such undertakings. National Register areas of significance include government and recreation. The period of significance dates from the initial construction of the trail in 1936 through the end of the historical period as defined by the National Register. This resource is included in the property type that includes resources associated with NPS administrative development, and this nomination is part of the Bryce Canyon National Park Multiple Property Submission.

The Riggs Spring Fire Trail represents the last segment of administrative fire trail constructed by CCC enrollees from Camp NP-3, during the 1936 field season. This segment of trail provided access to the southern-most backcountry areas of the park, and supplemented the access provided by the major administrative trail, the Under-the-Rim Trail. The design and construction of this trail fell under the auspices of the park engineer and landscape architect, and the trails system as a whole was included in park mater planning documents. The availability of CCC labor enhanced the ability of the park to complete construction of various administrative facilities, including the park circulation system.

The segment of the Riggs Spring Fire Trail that parallels Lower Podunk Creek likely overlaps a previously existing road or trail. Riggs Spring, located in the Lower Podunk Creek drainage, is a reliable source of water even in dry years, and local ranchers used the spring and the drainage corridor prior to the establishment of the park. Indeed the relatively gentle grad of Lower Podunk Creek on the east side of Yovimpa Pass paired with that of Podunk Creek on the west side of the pass offers an effective travel corridor linking the top of the plateau with the valleys to the east. Historical maps indicated that a two track road led southeast from the park boundary. A similar road provided access from the E. Fork of the Sevier River west to Yovimpa Pass.




