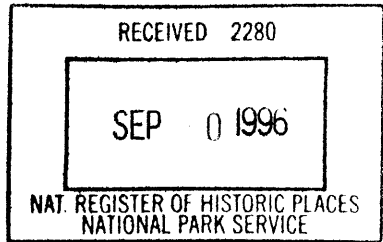

A detailed description of the physical characteristics of the stone is given in the Boundary Markers of the Original District of Columbia Multiple Documentation Form.

The East Corner Stone is located 100 feet east of the intersection of Eastern and Southern Avenues. The sandstone marker is in good condition. A 5' iron fence, also in good condition, surrounds the marker.

An expanded statement of significance is given in the Boundary Markers of the Original District of Columbia Multiple Documentation Form.

The East Corner boundary stone was the seventeenth marker to be located in Maryland. It was laid in 1792. Its fence was dedicated on April 15, 1916 by the District of Columbia Chapter, Daughters of the American Revolution.
