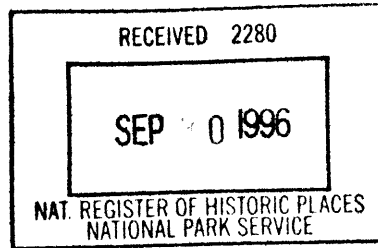

Intermediate boundary marker Northwest #8 is located at 6422 Western Avenue, approximately 65 feet from the centerline of the Avenue. The sandstone marker is in good condition. Its fence has been removed.

An expanded statement of significance is given in the Boundary Markers of the Original District of Columbia Multiple Documentation Form.

Northwest #8 boundary stone was the fifth marker to be located in Maryland. It was laid in 1792. It is located in the front yard of the residence. Its fence was dedicated on November 4, 1916 by the Colonel John Donelson Chapter of the Daughters of the American Revolution; it is not known when or why the fence was removed.

Verbal Boundary Description:

The stone is located in the front yard of 6422 Western Avenue approximately 65 feet from the center line of Western Avenue and 145 feet from the edge of Pinehurst Circle.

The boundary stone has historically been situated at this point and maintains historic integrity.
