# **Recent Success**

## **Carson Valley Trails**

The Carson Valley Trails Association (CVTA), in partnership with Douglas County, The Nature Conservancy, Carson City, Nevada Land Trust, Forest Service, Bureau of Land Management (BLM), and many community partners are working to implement a 100-mile loop trail that will provide access to the Carson Range, Pine Nut Mountains, Pony Express National Historic Trail, and Tahoe Rim Trail, and a system of shorter trails that connect to adjacent communities.

To date, over 40 miles of trails, trailheads, interpretive signs, and maps have been completed through grants, local donations, and thousands of volunteer hours. Most recently, the CVTA raised funds for expedited trail planning on BLM lands, resulting in the approval of an additional 5-mile segment.

Building on a vision established by the Douglas County Comprehensive Trails Plan and CVTA Strategic Plan, NPS staff supported the project by facilitating landowner outreach team meetings, creating outreach materials, and preparing a template for trail easements. The landowner outreach team continues to work together to develop partnerships with landowners and complete trail connections.

## 1. Beatty Habitat Trails

Establish a one-mile trail with interpretation and amenities along the Amargosa River as it travels through the center of Beatty.

Develop a conceptual plan that builds upon the previous Beatty Trails and Gateway Design Workshop and defines a more detailed trail alignment and design.

## 2. Black Canyon Water Trail

Promote and increase awareness of this 30-mile segment of the Colorado River. Establish a long-term water trail partnership.

Facilitate agreement on the vision, goals, and roles for the Lower Colorado River Water Trail Alliance and prepare content for outreach products.

#### 3. Sierra Vista Park

#### **Project Goal**

Transform a 206-acre previous golf course into a community asset that includes trails, recreation, and restored native habitat.

#### **NPS Role**

Facilitate the development of a shared vision and conceptual plan for Sierra Vista Park through community engagement and a design charrette, completed in partnership with the American Society of Landscape Architects (ASLA).

## 4. Winchester Community Garden
