Recent Successes cont.

Monongahela River Towns Program goes Paddling!

The Monongahela River Towns Program, an initiative of the Pennsylvania Environmental Council, got off to a quick start, thanks to a 3-year Claude Worthington Benedum Foundation grant. RTCA was asked to assist in the development of a public involvement strategy for guided paddling trips. RTCA staffer, Peggy Pings, led a short series of paddling events on Dunkard Creek and the Mon River in fall 2011 to spring 2012, many with the assistance of the Harry Enstrom Greene County Chapter of Izaak Walton League. Trips were successful, and usually boasted 12-33 participants. The River Town Program, in partnership with the Student Conservation Association, developed two more trips on the Mon during the summer and fall of 2012, complete with a guide service and volunteer lunchtime presenters.

One of these day-long Sojourns was funded by a \$900 grant from Pennsylvania Department of Conservation and Natural Resources and Pennsylvania Organization for Watersheds and Rivers (POWR). These events resulted in a greater appreciation for how River Towns can capitalize on their riverfronts to attract more paddlers. A database of over 200 people has been compiled due to this fantastic interest in the serene river experience, and some interested paddlers are now buying boats of their own. As time goes on, additional public access sites will be developed and promoted as part of the River Town Program offerings.

Recent Successes

Schoolyard Greening in Philadelphia

Students at the William Dick School are exercising their basic right to play! The students, with the help of the Trust for Public Land (TPL), are working to transform their asphalt-paved, schoolyard

into an inviting space for outdoor recreation. Using a 10-week participatory design curriculum, TPL and RTCA Fellow Sophie Sarkar engaged 50 students in the design of their own improved green schoolyard, including lessons on play culture, lighting and shadows, stormwater management, and playground design. These lessons helped students develop the tools necessary to design a safe, ecologically beneficial, and economically feasible

schoolyard. At the end of ten weeks, the students had developed several alternative designs, which informed the final professional design of their new schoolyard.
