Location: Trail connecting the City of Van Buren to Ozark National Scenic Riverways, along the Current River.

Congressional District(s): MO-8

Project Goal

A 10.2-mile multi-use trail along the Current River in Carter County, Missouri, via county road and service road enhancements that will connect Van Buren to land and water resources of Ozark National Scenic Riverways.

NPS Role

Assistance in the development of a master plan for the trail project as well as assistance identifying funding sources that might be used in the development and marketing of the trail. We will also need help in moving ideas into action and realizing our vision

2. Kansas City Rock Island Trail

Project Partner: Mid-America Regional Council

Location: A 30 mile former RR corridor will connect the Kansas City

Metro region to the Katy Trail (Central MO).

Congressional District(s): MO-4,5

Project Goal

MARC will acquire title to the 30 mile rail corridor for rail-trail development.

NPS Role

Staff will work w/ MARC staff to develop a plan to acquire the RR ROW. The Rock Island RR has not yet sold the corridor to MARC.

3. Mississippi River Trail & Collaborative Support

Project Partner: Mississippi River Trail,

RTCA Contact: David Thomson Location: Headwaters of Mississippi River in Minnesota to Gulf of Mexico, New Orleans.

Congressional District(s): AR-1, 4; IA-2, 4; IL-4, 12, 16, 17, 19; MN-2, 3, 4, 5, 6, 8; MO-1, 2, 3, 8, 9; WI-3

Project Goal

Locally: Develop 71 miles of trail from Vicksburg, MS to Natchez, MS. Nationally: Create a network of 3,000 miles of trail from Minnesota to Louisiana.

NPS Role

Provide facilitation assistance in support of the development of segments of the MRT in Mississippi through outreach and MRT Workshop Planning. Provide facilitation assistance towards developing framework for Mississippi River Connections Collaborative as outlined in a Memorandum of Understanding, by and between, the National Park Service, U.S. Fish and Wildlife Service, and Mississippi River Trail, Inc.

4. Mounds Heritage Trail

Project Partner: The Confluence Partnership

Location: City of St. Louis, St. Clair and

Madison Counties

Congressional District(s): IL-12, MO-1,3

Project Goal

Develop a nine-mile on-road interpretive trail, with links to two miles of off-road interpretive trails at Cahokia Mounds that will focus visitors on the rich cultural and natural attributes of the area.

NPS Role

RTCA staff will serve on the Technical Advisory Team to this project, and assist with community outreach and technical support. Community input for the project will be needed from a number of jurisdictions and building that support will require individuals knowledgeable about community development, local culture and trail development. RTCA will assist with this outreach effort to Illinois and Missouri communities. RTCA staff may have information on comparable heritage trail projects nationally that could be models.
