# **Recent Successes**

# River Bend Trail – Concept Plan Design and Report Completed

Merrill, Wisconsin is a small community that extends one mile by five miles along the Wisconsin River's undulating bends. Civic leaders, recognizing the juxtaposition of the beautiful river and the abandoned railroad tracks, as well as pedestrian use of the area, formed the idea of a riverfront trail. The 2.5-mile trail would connect major parks on the city's western edge to downtown, while providing a safe, attractive alternative transportation route. The proposed trail corridor contains historic commercial and industrial buildings, as well confluence with the Prairie River, recognized for its trout fishery. The proposed trail is poised to link with the Ice Age National Scenic Trail and form part of the spine of a proposed state trail.

# 1. Fox-Wisconsin Heritage Parkway Water Trail

Project Partner: Fox-Wisconsin Heritage

Location: Green Bay, Brown, Prairie du Chien, and Crawford Counties Congressional District: WI - 3, 8

### **Project Goal**

Ultimately this water trail will be a well-marked, easily-portaged, ADA-accessible 280-mile water trail along the historic Fox and Wisconsin Rivers connecting the Mississippi River with Green Bay in Lake Michigan. Outcomes include selection of format and begin work on website and print materials; improved designs for portages around locks and dams on the historic canal; and agreed upon safety measures to adopt along the river.

### **NPS Role**

Assist in developing outreach/ educational materials (map/brochure) and website; improve portage design to better withstand seasonal flow damage; and assist in addressing safety concern around dams. As time permits, also assist with recommendations on developing sustainable programming events such as the annual Heritage Paddle; and assist with making the portages ADA accessible and studying impacts on user health.

## **Project Goal**

A 533-mile water trail along the Wisconsin Shorelines of Lake Michigan and Green Bay. A gap analysis identifying zones where public access is needed; these would be targeted for future land acquisition. Develop a branding strategy/logo and provide educational opportunities to encourage better understanding of the need to help protect the lake's ecosystem. Develop website and brochure to improve paddler experience.

Contribute expertise in developing previous large water trail projects, e.g., Lake Superior Water Trail. Lead public participation efforts. Facilitate future

partnerships with organizations that can help implement/build the water trail. Provide technical assistance in developing logo, brochure, website, interpretation panels, and National Water Trail System application.

### **Project Goal**

The project will identify and map out a 170-mile greenway corridor associated with the Niagara Escarpment geological formation. Existing resource and recreation-based nodes will be identified in order to develop a connected network of regional and local sites which may include off-road and on-road walking and bike trails/ routes as well as driving routes.

#### **NPS Role**

Assist with revising goals and objectives for the draft greenway plan; assist in the assessment of resources, particularly aesthetics; assist in the development of a concept plan with broad indications of 1) greenways which incorporate priority conservation areas and 2) a wide main corridor and side trail connectors. Assist in developing public involvement and media relations. Assist in identifying potential funding sources and strategies for implementation.

# Planning Connections: Milwaukee County Grounds Trail Plan and Report Completed

Synchronicity of events forges new ideas, opportunities, and actions. Such is the genesis of this project where diverse ideas and activities began to evolve around a large, publicly-owned, natural open space, proposed university research facilities and

office/residential developments, and a proposed reconfiguration of a major highway intersection in the heart of the Milwaukee metropolitan area. Many stakeholders, from recreational users to new and existing institutional neighbors, converged to define issues and potential solutions to preserve open space, define connecting trails, and provide guidance to future adjacent developments.

The solutions included linkages to Monarch Butterfly migration roosting habitat, Neo-Gothic "Historic Eschweiller Buildings," a regional medical research campus, naturalistic detention ponds, and a future forestry exploration center. "The trail guide that RTCA spearheaded for the Milwaukee County Grounds is a vital component in the planning for this diverse site. It will help integrate disparate elements into a unified whole that is greater than the sum of its parts."

The City of Wauwatosa recruited staff from RTCA who formed the planning committee and process; recruited graduate students to develop a map and graphics; coordinated public design workshops; wrote and oversaw production of the report that included recommendations for trails design, steps for implementation, and concept plans for connecting areas and infrastructure.
