Scouts Help at Wildlands Stewardship Day

The High Plains District Boy Scouts worked in below normal temperatures and high winds to create new trail signs and to build bluebird boxes for the Wildlands Stewardship Day held at Scotts Bluff National Monument. The signs will be placed at trailheads and along new trails on Wildcat Hills Wildlands.

The Wildcat Hills and adjoining prairies are located in the extreme western edge of Nebraska. It is a unique and endangered ecosystem including high prairie grasslands, wooded escarpments, spring-fed canyons, as well as riparian areas - all open to the public. The Wildlands is home to Big Horn sheep, deer, elk, and a variety of waterfowl and upland birds.

The region has been conserved largely because ranchers maintained the wide-open spaces and high quality of the native prairie. These landowners are now working with Platte River Basin Environments, Inc. (PRBE), Nebraska Game and Parks Commission, and The Nature Conservancy to preserve an ecologically

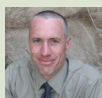

Nebraska Park has New Campground and Trail Extension Built through Partnership

Horse riders will enjoy a new campground and trails at Branched Oak State Recreation Area north of Lincoln, Nebraska. This was a joint project between the Nebraska Horse Trails Committee (NHTC) and Branched Oak State Recreation Area with assistance from RTCA staff member, Mary Hanson.

NHTC provided funds and initial design work for the Nebraska Recreational Trails Grant application. The park completed the engineering specifications and provided construction crews and equipment. A special feature is an accessible mounting ramp

Project Goal

Restore the riparian corridor along the North Fork River in Norfolk's downtown and construct a water trail that will increase recreational opportunities for the residents and tourists.

NPS Role

RTCA staff will provide information and facilitate meetings on river redevelopment, paddling sports, and natural resource enhancement in urban settings. RTCA's goal will be to assist in developing specifications for engineering study and funding strategies.

2. Ponca Pines Academy Gardens

Congressional District: NE - 2

Project Goal

The girls at Ponca Pines Academy will become engaged through a variety of activities, a community garden being one, which will demonstrate the potential of pursuing an education and vocation in natural resources.

NPS Role

RTCA will engage in sessions with the girls Ponca Pines Academy to encourage their pursuit of studying in a natural resources field of study. In addition, RTCA will work with the girls and staff to design and plan for the construction of a trail network on the Uta Halee grounds.

3. Wildcat Hills Wildlands Recreational Trails Development

Project Partner: Platte River Basin Environments, Inc.
RTCA Contact: Mary Hanson
Location: South of Gering, Nebraska
Congressional District: NE -3

Project Goal

Create approximately 20 miles of sustainable backcountry trails while supporting wildlife habitat and ranching activities. Build new environmental education programs highlighting the high prairie of western Nebraska.

NPS Role

Continue locating optimal locations for trails and facilitate meetings to implement the trail plan. Work with Boy Scouts on trail design activities and signs, implement a Leave No Trace training to involve more youth in outdoor activities, and work with the Discovery Center in Scottsbluff, Nebraska to use the Wildcat Hills for environmental education programs.
