# **Recent Successes**

## **Bakersfield Community Trails**

The small town of Bakersfield, Vermont created its first conservation commission just over 2 years ago and already they have achieved significant conservation successes. The Commission created a new Town Park and launched Bakersfield Community Trails, a planned community trails system that includes Village Center Trails, Conservation Trails and Historic Trails highlighting the area's unique natural resources, historic legacy, and scenic beauty. Successful grant applications, public events and community partnership have led to a new trail, signage and a partnership with the Vermont Youth Conservation Corps that will help the Commission create needed infrastructure at the Town Park. Bakersfield trails volunteer Larry Krygier notes, "Lots of Bakersfield citizens are getting excited. I keep running into people who want to be a part of the project."
