
#### **ABOUT US**

## **Recent Successes**

## Moses Lake Takes Health Seriously

When the Washington State Department of Health chose Moses Lake as a pilot to test its new plan for physical activity and nutrition, the community responded with a priority action to develop a network of pathways. RTCA helped the steering committee with trail planning, bilingual outreach, and a design workshop co-sponsored with the American Society of Landscape Architects. Since then, the city has leveraged more than \$2,000,000 through partnership efforts, built more than 12 miles of trails, initiated a Safe Routes to School Program, and is able to offer recreation and health programs for truly active living in Moses Lake.



# Kids Make a Difference for Clark's Creek

In 2002, the Puyallup River Watershed Council asked RTCA to help address pollution issues in Clark's Creek. RTCA brought in "artists-in-residence" who worked with local school children to create artwork, stories, and poems reflecting the conservation messages for grown-ups. The resulting kid-friendly publication, "I am

Clark's Creek," spurred citizens to form Friends of Clark's Creek, a local advocate for creek clean-up activities. Illegal discharges have been stopped, an upstream fish hatchery made improvements to water quality, and many land owners have implemented creekside restoration along their properties.

## **Current Projects**

## 1. Blackjack Creek Wilderness Trail

Lead Partner: City of Port Orchard

The project partners want to create a 1.25 mile 'wilderness' trail along a natural, heavily vegetated salmonbearing stream that flows through Port Orchard to Puget Sound. With RTCA assistance, the city will hold public workshops and meetings to finalize details for the trail and produce a publically supported concept plan for trail construction.

### 2. Chewelah Creek Path

Lead Partner: City of Chewelah

With assistance from RTCA, the City of Chewelah will update a 17-year-old plan for a pathway along the creek that flows through town and explore secondary trail loops. Partners hope the path will connect city parks, City Hall, neighborhoods, and schools and build awareness and support for habitat restoration along the creek.

## 3. Dishman Hills-Iller Creek Conservation Corridor

Lead Partner: Inland Northwest Trails Coalition

A diverse group of non-profit and public organizations in metropolitan Spokane are partnering to establish a corridor between two established conservation areas. The surrounding environment provides critical habitat,

serves as a wildlife migration corridor, displays Ice Age flood formations, provides cherished views, and has the potential to link two trail systems. RTCA will assist the partnership with engaging nearby neighborhoods in the planning effort.

## 4. Five Mile Prairie Loop Trail

Lead Partner: Spokane County Division of Engineering & Roads

Trail proponents want to create a network of public trails that connect residents, neighborhood destinations

and natural areas before the opportunities are lost to residential growth and development. Safe routes for school-bound children are a critical component of the plan.

## 5. Glacier Community Trail

Lead Partner: Glacier Community Trail Committee

RTCA is working with trail partners to build a stronger coalition to champion design and construction of a 1.5-mile non-motorized trail that connects the small town of Glacier with the Mount Baker Snoqualmie National Forest.

# 6. Green River Gorge Greenway

Lead Partner: Middle Green River Coalition

The Middle Green River Coalition was formed to protect and enhance the "best of the last wild places in King County" for habitat health and passive recreation opportunities. RTCA is assisting the coalition in the planning and

publication of a greenway management plan that establishes a coordinated management structure for the conservation of natural and cultural resources, and appropriate access for public recreation.

### 7. North Kitsap String of Pearls Trails

Lead Partner: North Kitsap Trails Association

RTCA is working with trail partners in North Kitsap County to plan a 50-mile

system of trails that, like a string of pearls, links communities, tribal lands, park and public lands, and 8,000 acres of private development owned by the Olympic Property Group. More than 500 people attended the first trail information meeting and public involvement will continue to shape the final concept plan.

## 8. NE Seattle Neighborhood Trails

Lead Partner: Feet First

RTCA is helping Feet First and neighborhood groups develop a walking map, trail network, and wayfinding system for NE Seattle. The goal is to increase physical activity by making walking around the community easier. A trail and sidewalk inventory and prioritized list of improvements will also be developed to guide creation of safe walking opportunities.

## 9. Pend Oreille Water Trail

Pend Oreille River Tourism Alliance

RTCA is helping trail partners develop a

plan for a 70-mile recreational boating route along the Pend Oreille River. Key goals are to preserve habitat, boost the local economy, and establish destinations for research and education within the river corridor.

## **10. Pierce County Open Space**

Lead Partner: Pierce County Parks & Recreation Department

RTCA is facilitating an Open Space Task Force, appointed by the Pierce County Council, on a project to undertake a comprehensive review of open space resources and financing options in the development of recommendations for a coordinated and robust countywide open spce preservation effort.

## 11. Poulsbo Urban Trail System

Lead Partner: City of Poulsbo Parks & Recreation Department

The recent "Project Poulsbo" visioning process showed a strong desire by citizens to walk and bike. RTCA will help the City, partners, and citizens prepare an urban trail plan that will result in an 8-10 mile trail network connecting the Liberty Bay waterfront with neighborhoods, parks, downtown shopping, and schools. The trail system will also be linked to regional trails on the Kitsap Peninsula and readily accessible to the many people who arrive in Poulsbo by boat.

## 12. Puget Creek Restoration

Lead Partner:

**Puget Creek Watershed Alliance** 


RTCA is helping the Watershed Alliance sponsor a visioning process to bring conservation partners and neighborhoods together to forge a vision for the Puget Creek Watershed. Daylighting the creek, restoring native plant communities, building bioswales, and using tertiary wastewater to sustain a salmon run are all part of the possibilities. Key stakeholders include the Duwamish Tribe, Nature Consortium, People for Puget Sound, Seattle Parks & Recreation, Duwamish River Cleanup Coalition, and others.

### **13. Seattle Trail to Treasure**

Lead Partner:

Pioneer Square Community Association

RTCA is helping the Pioneer Square Community Association convene community stakeholders, including the Klondike Gold Rush National Historical Park, to plan a recreational trail through the historic Pioneer Square neighborhood of Seattle. Project goals include communicating the early history of Seattle, the impact of the Klondike Gold Rush on its development, and how that story is relevant today.

#### 14. South Cowlitz River Trail

Lead Partner: City of Longview Parks & Recreation

The City of Longview and RTCA are working with the Cowlitz Health Department, nonprofit health advocates and other partners to conceptualize another connecting loop trail, resulting in nearly 32-miles of trail paralleling the Cowlitz River. Future phases of the trail are expected to connect with towns in the Columbia River corridor.
