# **Recent Successes**

## **Passaic River Blueway**

The NJ Department of Environmental Protection and the Federal Highway Administration have awarded a National Recreational Trails Grant to the Passaic Valley Sewerage Commissioners (PVSC) and their local project partner the Lower Passaic Watershed Alliance (LPWA) to implement the next phase of the Passaic River Blueway project. PVSC and LPWA will work with municipalities along the Passaic River to develop signage and a map & guide of the water trail.

The Passaic River Blueway works to establish 25 public access points on the 32-mile lower Passaic River Blueway water trail. Flowing out of the Great Swamp National Wildlife Refuge, the upper Passaic River is less developed than the lower portion, and will provide paddlers with a contrast from the urban experience of the lower 32 miles of river.

### **Project Goal**

31-mile water trail linking greenways along the Raritan River; educational and outdoor recreation opportunities for families; enhanced appreciation and stewardship of environmental, recreational, and historic resources.

#### **RTCA Role**

Assist with development of public access management plans and riverbased recreational programs.

## 2. Delaware River Resource Protection Strategic Plan

A 5-year strategic plan for the Delaware River Greenway Partnership, focused on its role in protection and stewardship of the natural, cultural and recreational resources of the Delaware River region in New Jersey and Pennsylvania.

Facilitate a strategic planning process and assist with producing an action plan; assist with capacity-building of long-time NPS partner organization.

## **Project Goal**

32 acres of restored and enhanced wetland habitat; improved health of adjacent Cooper River; new waterfront access, nature education opportunities, and connections to the regional trail network for urban community members.

## 4. Morris Canal Greenway

## 5. Rutherford Bicycle Ring

Project Partner: Rutherford Green Team RTCA Contact: Jerry Willis Location: Bergen County, New Jersey Congressional District: NJ-9

### **Project Goal**

A five mile network that links bicycle routes, bike lanes, and off road bicycle paths with future connections to other southern Bergen County attractions and natural areas such as the Hackensack Meadowlands.

#### **RTCA Role**

Assist with organizing resident focus groups and evaluating the needs and concerns of the community; assist with route planning, constituency building and identifying funding, as well as coordinating efforts with the Passaic River Blueway, The Hackensack Riverkeeper, The NJ Meadowlands Commission and other neighboring organizations and municipalities.

# 6. September 11th National Memorial Trail

A 1,100-mile hiking, biking, and driving trail physically connecting the three national memorials commemorating the tragic events that occurred in 2001.

#### **RTCA Role**

Facilitate determination of trail route through New Jersey and assist in the development of an interim Strategic Plan to improve organizational capacity and ensure quality trail management.
