1. City of Avoca River and Trail

Project Partner: City of Avoca RTCA Contact: David Thomson Location: Along two forks of the West Nishnabotna River Congressional District(s): 5

Project Goal:

Build five miles of land-based multi-use trails, 15 miles of river enhancements and water trails, and four acres of wetland and park area restoration.

RTCA Role:

Assist the City of Avoca, develop dialogue between the project partners and facilitate input into a conceptual plan for each part of this outdoor recreation project. This project has a strong landbased trail component, as well as a river and water trail component.

2. Hitchcock Nature Center Trail Expansion

Project Partner: Pottawattamie County Conservation Board RTCA Contact: David Thomson Location: Council Bluffs Congressional District(s): 5

Project Goal:

Develop three miles of new trail connecting over 30 miles of existing primitive trails.

RTCA Role:

Assist with the sustainable development of the Hitchcock Nature Center trail expansion. Provide examples of trail construction details and approaches to planning a new trail system.

3. Mississippi River Connections

Project Partner: Mississippi River Trail, Inc.

RTCA Contacts: Diana Allen, Randy Thoreson

Location: Headwaters of Mississippi River in Minnesota to Gulf of Mexico, New Orleans

Congressional District(s): 2, 4

Project Goal:

Through connections with 18 National Parks and Trails, build a collaborative partnership that highlights and enhances 3,000 miles of trail (land and water) and 30,000 acres of open space along the entire Mississippi River corridor.

RTCA Role:

Provide support and services, including facilitation, research and coordination to the Mississippi River Parks and Trails Collaboration to help partners showcase the Mississippi River as a valuable national natural resource and recreation corridor. RTCA services will enhance local, state, regional and national efforts to: 1) protect and preserve the Mississippi River and the Mississippi River Trail as a national landscape; 2) demonstrate the impact of partnership development by and between National Park Service superintendents and other public and private partners.

4. Upper Des Moines River Land and Water Trails

Project Partner: Prairie Partners RC&D, Humboldt Area Trails Co. RTCA Contact: David Thomson Location: North Central Iowa Congressional District(s): 4

Project Goal:

Develop 50 miles of water trail and 10 miles of land trails connecting to communities in north-central lowa.

RTCA Role:

Assist local trail and community groups to connect existing trail and water trail systems. Provide examples of other regional efforts to connect natural resources and community benefits of developing a trail system. Also assist with community involvement.

5. Webster County Water Trails

Project Partner: Webster County Water Trails RTCA Contact: David Thomson Location: Fort Dodge area Congressional District(s): 4

Project Goal:

Develop 19 miles of water trail and three miles of riverfront enhancements.

RTCA Role:

Assist local leadership to build a broad base of support for the project. Provide technical assistance with project phasing, scope of work, selection of river access areas, mapping, and general community involvement.
