

House was one of first built when Bennettsville became Marlboro County Seat in 1824. According to tradition it was used as Union Army headquarters by Maj. Gen. F.P. Blair when Sherman's men captured and occupied town March 6-7, 1865.

House was built by Dr. E.W. Jones, who purchased four-acre site on which it originally stood in 1826-1827. It derives its name partially from being owned from 1854-1904 by the family of Dr. Beaty Jennings, who bought it.

A drawing in Frank Leslie's TLLUSTRATED, April 8, 1865, shows Union troops encamped on the Court House Square directly opposite this house.

7. Description

When the Jennings-Brown House was moved in 1900, the gable on the front was added as well as a sleeping porch (now gone) which was built over the front porch.

Plans are to restore the house to its original condition by restoring brick chimneys at either endof house; replacing present porch with shed-style, one-story porch supported by round columns on brick pillars outside the porch flooring; removing ornamental front gable.

The Marlboro County Historic Preservation Commission and the Marlborough Historical Society are seeking state and federal funds for restoration of the Jennings-Brown House, to be used as a house museum and community meeting hall.

8. Significance

Architecturally, historically and militarily significant, the Jennings-Brown House was built by Dr. E. W. Jones, one of Bennettsville's earliest physicians, on a four acre site which he purchased in 1826-27. It was one of the first houses built after Bennettsville became the Marlboro County seat in 1824.

Architecturally, this house is important as Bennettsville's only remaining two-story home built prior to 1853. It is recognized as a town and area landmark and before being moved in 1900 and subsequently altered, was an authentic example of the fine homes built in this area c. 1830. (See attachments)

Historically and militarily, the Jennings-Brown House was significant as headquarters for Major General Frank P. Blair, commanding general of the U.S.A. XVII Army Corps, which captured and occupied Bennettsville on March 6-7, 1865. Local evidence verifies this. A drawing in Frank Leslis's <u>Illustrated</u>, April 8, 1865, shows Union Army troops encamped on the Court House Square, directly opposite this house.(See attachments)

Dr. Jones sold the house in 1834 and migrated to Mississippi. Subsequent owners were the family of Dr. J. Beaty Jennings (1854-1904) and the J.J. Brown family (1930-1968).
